Office Hours: Monday-Friday, 8:00 am to 4:00 pm, except school holidays

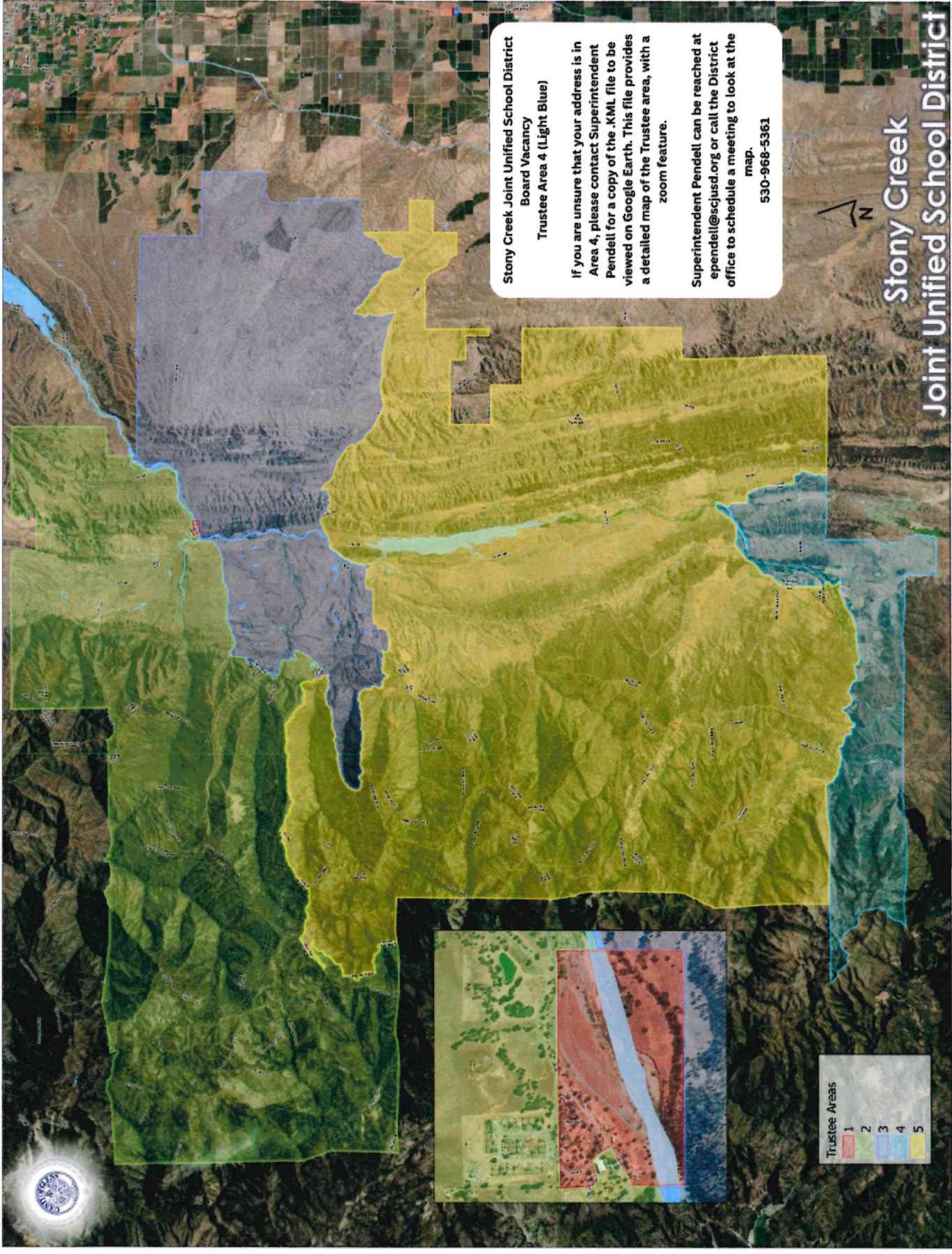
