Baig Shall the Board of Trustees of School District No. 288, Latah & Clearwater Counties, State of Idaho, be authorized and empowered to levy a Supplemental Juliana Bollinger Levy in the amount of Eight Hundred Eighty Thousand dollars (\$880,000) per one (1) year, commencing with the fiscal year beginning July 1, 2023 and ending June 30, 2024, for the purpose of financing any lawful expenses of maintaining and operating the District; all as provided in the Resolution adopted by the Board of Trustees on March 6, 2023. The estimated average annual cost to the taxpayer on the proposed levy is a tax of \$288.10 per \$100,000 of taxable assessed value, per year, based on current conditions. The proposed levy replaces an existing levy that will expire on June 30, 2023, and that currently costs \$364.00 per \$100,000 of taxable assessed value. If the proposed levy is approved, the tax per \$100,000 of taxable assessed value is expected to decrease the tax by \$75.90 per \$100,000 of taxable assessed value.
