Beecher200U is going one step further. We are granting every parent a free Qustodio Parental App account. Qustodio will give you important insights into your child's online activity on their school device. You can use it to review and manage activities on other devices in your home too.

- -One dashboard to view, track, and limit access to web and other apps




