

WEBSTER COUNTY BOARD OF EDUCATION
REGULAR SESSION
JUNE 11, 2026 @ 6:00 P.M.

The Webster County Board of Education held its regular meeting on June 11, 2026 at 6:00 p.m. Linda Rogers, Donald Brown, Jimmie Johnson, Kim Shropshire, and Marc Maynor, Superintendent, were present. Landon Matthews was absent.

Linda Rogers called the regular session to order at 6:00 pm.

A moment of silence was observed followed by the Pledge of Allegiance.

Visitors were recognized by Linda Rogers.

The Board approved the tentative agenda for June 11, 2026. A motion was made by Donald Brown and seconded by Kim Shropshire. The motion carried unanimously.

The Board recognized Donald Brown's resignation from the Webster County Board of Education (BOE) effective June 11, 2026.

The Board approved the April 2026 Financial Report. A motion was made by Jimmie Johnson and seconded by Kim Shropshire. The motion carried unanimously.

The Board reviewed the reconciliation report.

The Board approved the May 12, 2026 (6:00 pm) regular session minutes. A motion was made by Donald Brown and seconded by Jimmie Johnson. The motion carried unanimously.

The Board approved the budget hearing #1 minutes (May 12, 2026). A motion was made by Kim Shropshire and seconded by Donald Brown. The motion carried unanimously.

The Board approved the budget hearing #2 minutes (May 20, 2026). A motion was made by Jimmie Johnson and seconded by Kim Shropshire. The motion carried unanimously.

The Board approved to enter into executive session. A motion was made by Donald Brown and seconded by Jimmie Johnson. The motion carried unanimously.

The Board approved to exit from executive session. A motion was made by Donald Brown and seconded by Kim Shropshire. The motion carried unanimously.

The Board approved the proposed pay dates for the FY 27 school year. A motion was made by Jimmie Johnson and seconded by Donald Brown. The motion carried unanimously.

The Board approved the final 2026-2027 budget. A motion was made by Kim Shropshire and seconded by Jimmie Johnson. The motion carried unanimously.

The Board approved to purchase Simbli through GSBA in the amount of \$5,100 (\$3,600 yearly subscription fee and \$1,500 initial set up fee) (local funds). A motion was made by Kim Shropshire and seconded by Jimmie Johnson. The motion carried unanimously.

The Board approved to pay Moore Heating and Air in the amount of \$17,520 to replace the media center A/C unit (local funds). A motion was made by Donald Brown and seconded by Jimmie Johnson. The motion carried unanimously.

The Board approved to pay SRJ Architecture \$65.25 for facilities and renovations project (bond grant). A motion was made by Jimmie Johnson and seconded by Kim Shropshire. The motion carried unanimously.

The Board approved to pay Sherridan Construction \$30,541.73 for facilities and renovations project, pay APP #12 (bond grant). A motion was made by Jimmie Johnson and seconded by Kim Shropshire. The motion carried unanimously.

The Board approved to pay Sherridan Construction \$122,971.57 for facilities and renovations project, pay APP #13 (bond grant). A motion was made by Jimmie Johnson and seconded by Donald Brown. The motion carried unanimously.

The Board approved OT contract for services with Therapeutic Learning Center of Thomaston, Inc for the 2026-2027 school year. A motion was made by Kim Shropshire and seconded by Jimmie Johnson. The motion carried unanimously.

The Board approved the speech contract for services with Cynthia G. Kelley, SLP for the 2026-2027 school year. A motion was made by Jimmie Johnson and seconded by Kim Shropshire. The motion carried unanimously.

The Board approved the updated Board Policy GASB 87 descriptor code. A motion was made by Donald Brown and seconded by Jimmie Johnson. The motion carried unanimously.

No new business was discussed.
