E. FACILITIES UPDATE – PE ELL. PeEll staff updated the group on PeEll facility improvements. The fitness center, shop, gym are now classrooms for two years. They have set up batting cages at Magruder's shop as well as a wrestling room upstairs. Next year, all football games will need to be held at Willapa Valley due to the PeEll field being worked on.

F. FACILITIES UPDATE – WILLAPA VALLEY. Willapa Valley staff updated the group on Willapa Valley facility improvements. The Lebam property has been filled and reseeded where the school was. The space will now have a football practice field as well as a softball practice field. The staff has put in for grants to purchase some items for the fields. The field is a bit short for baseball. The Lebam bus garage is being cleaned out to move the bleachers out of the gym. The gym will have permanent batting cages installed. The nets and cables are ordered. The Lebam gym has a storage space available for team gear.

G. SPRING FACILITY PLAN. The coaches will work with the athletic directors to create a plan for practice especially during inclement weather. There was discussion about the PWV agreement. No action was taken.

H. ADJOURNMENT. The meeting was adjourned at 5:59pm.
