## SKYLINE HIGH SCHOOL PARKING GUIDELINES & RULES

Driving to school in a personal vehicle is a privilege afforded students at Skyline High School who demonstrate responsibility and proper safety. Parking Tags and registration are required to park a vehicle on school property.

- 1. <u>Effective 7/1/2022</u>; The VDOE issued code of Virginia 22.1-205.1 requiring public high school students to provide evidence that the student possesses a valid driver's license or driver privilege card. It also requires high school to utilize a standard application form.
- 2. All student vehicles must be parked in your <u>assigned parking space</u> in the student parking lot that is adjacent to the football stadium. NO PARKING IN FACULTY/VISITOR OR BUS LANE LOTS!
  - a. Space numbers 001- 226 will be assigned to students as they return their registration form and must be parked in the stadium parking lot. Your parking tag # will correlate to your assigned space.
- 3. 10<sup>th</sup> grade students are eligible for a parking permit in January, 2<sup>nd</sup> semester with approval from an administrator based on passing grades in all classes & not having excessive tardies to school.
- 4. Students are not to return to their vehicles for any reason once they enter the building. In an emergency situation a school administrator may give a student permission to return to the vehicle/ parking lot.
- 5. Vehicles should be locked. The high school is not responsible for lost, damaged, or stolen items.
- 6. All vehicles must be properly registered and students must comply with all laws of the Commonwealth and Town and County codes.
- 7. A ticket may be issued to an illegally parked vehicle.
- 8. Students may not transfer parking permit tags to other students.
- 9. The parking permit must be attached on the rear view mirror any time the vehicle is on the school premises.
- 10. Students must obey all driving regulations while operating a vehicle on school property. Pedestrians and school buses always have the right of way on school grounds.
- 11. At the end of the school year students <u>MUST return your parking tag</u> to Mr. Allison or the front office. Unreturned tags will result in a \$10.00 fine.

<u>FEES</u>: SENIORS: \$15.00 & UNDERCLASSMEN: \$30.00. All students after May 1<sup>st</sup> \$5.00. You must present the following with payment in order to obtain a valid parking tag/space:

- Valid Driver's license or driver privilege card/paper.
- Completed VDOE HS Parking Pass application with parent signature
- Sophomores must receive administrators signature (only eligible 2<sup>nd</sup> semester)

Students will lose their right to park at Skyline for violations of the standards for student conduct as listed: Leaving school without permission, Transporting students off campus who do not have authorization to leave, Excessive tardies to school, Improper driving, Improper parking, illegally transporting students not in accordance with state codes.

Repeat offenders may have their right to park revoked for the remainder of the year. Parking fees will not be refunded to students who have their right to park revoked.

As stated in the Warren County Public Schools Student Code of Conduct: "Students are permitted to park on school premises as a matter of privilege, not of right. The school retains authority to conduct routine patrols of student parking lots and inspections of the exteriors of student automobiles on school property. The interiors of student vehicles may be inspected or searched whenever a school official has reasonable suspicion to believe that the student has violated or is about to violate the law or a school rule and that the search will yield evidence of the violation, or that illegal or unauthorized materials or other evidence of illegal or otherwise prohibited activities are contained inside the automobile. Such patrols and inspections may be conducted without notice, without student consent, without a search warrant, and with the use of canine surveillance."
