

Pursuant to the law (Title I, Part A), a meeting of the parents of Title I students shall be held each year. Parents will have the opportunity to complete a survey that addresses planning, review, and improvement of the Title I Program. Texline ISD has provided for a "School-Wide" Title I program since 1996-1997. Therefore, ALL students are eligible to be served, and ALL parents shall be given the opportunity to complete this survey. The survey (and any suggestions for improvement in the Program) shall be discussed, and any improvements agreed upon will be incorporated in the Title I Program and the SCHOOL/PARENT COMPACT for the following vear.

The Title I program is designed to meet the specific needs of the eligible children attending your child's school. Title I programs are also designed to improve the educational opportunities of underachieving children and help them.

- Succeed in the regular program
- Attain grade level proficiency, and
- Improve their achievement in the basic and more advanced skills.

Title I support programs include parental involvement, counseling, health care, and other social services. In addition, certain educational programs are available to pupils who live in target areas and attend private schools and to neglected children who reside in institutions designated by the Texas Education Agency.

RESPONSIBILITIES

It is known that high student performance is a shared responsibility. Improved achievement involves not just students, but parents, teachers, and administrators. Outlined in the Texline ISD Student Handbook, parent responsibilities include:

- Be sure their children attend school regularly.
- Make every effort to provide for the physical needs of their children.
- Teach their children to pay attention and obey all rules.
- Encourage and lead their children to develop proper study habits.
- Participate in meaningful parent/teacher conferences to discuss their children's progress.

Texline ISD, through the Title I Program, shall provide training opportunities for parents to enable them to work more effectively in their role as parents.

In order to become informed about the law, parents are encouraged to attend the Title I parental involvement meetings, and to participate in the various activities offered.

PARENT'S RIGHTS

Parents have the right to a copy of the law and an explanation of policy. Parents also have the right to contribute their input into the development of the Title I program, it's implementation and evaluation, and to have activities that are specifically designed to help them help their children improve their academic performance.

THE LAW


The most recent law that affect Title I is the IMPROVING AMERICA'S SCHOOL ACT (Public Law 102-382 [H.R.6]). The law requires:

- That school districts have a written policy regarding parental involvement;
- That parents be involved in the design, operation, and evaluation of Title I;
- That parents be consulted about home-school activities and be trained to help instruct their children;
- That whenever possible, activities should be presented in the language spoken by the majority of Title I parents.
