WCSD's Summer Institute for Educators

In June of this year, the WCSD Administrative Team hosted the first annual Superintendent's Conference. The Conference was designed to build leadership capacity within the school district and to serve as a vehicle to advance the district's vision and mission. All principals, assistant principals, curriculum specialists, media specialists, and all district-level instructional team members participated in the four-day conference.
