D. Climatec Energy efficiency lease update

Dr. Price and Mr. O'Shea discuss and reviewed with board members the Pro Forma Operational Savings hand-out provided by Brandon Woodward Sales Engineer with Climatec. If the district enters into a Lease Purchase Agreement with Climatec, the lease term will be 15 years with a lease rate of 2.963%. The hand-out provided a 15 year financial analysis with a detailed breakdown of program savings and program costs. Climatec noted in the event that Climatec does not meet the annual guarantee or the financial requirement of the state, Climatec will reimburse the District for the short fall.

E. Town Hall - News and Views

Dr. Price asked board members if they felt an end-of-year *News and Views* newsletter should be mailed in May. They all agreed this should happen.

Dr. Price asked about advertising meetings, and if we want to continue with the Community Linkage meetings. Board members all felt they'd like to continue with meetings, but felt conducting meetings during the summer would not be productive. They felt the community meetings should resume starting in September, with some meetings focused on gathering information, and offer meetings focused on providing information. They felt perhaps targeting specific groups would be beneficial too; for example, homeowners association board members.
