The Regular Meeting of the Chadwick-Milledgeville Community Unit School District #399 Board of Education was held at the Milledgeville School on Tuesday, January 17, 2023 at 7:03 p.m.

CALL TO ORDER: The meeting was called to order by the Board President, S. Baylor-Schmidt at 7:03 p.m. A motion was made by A. Drinkall and seconded by M. Bibler to approve the agenda. Voice vote showed 7 ayes and no nays. Motion carried.

Economic Interest Statements: Distributed and Collected Economic Interest Statements from Board. Superintendent Schurman reported that these statements are a yearly requirement of the state and need to be completed and turned in at this meeting.

Approved Board Retreat Meeting: A motion was made by P. Eubanks and seconded by M. Bibler to approve setting the Board Retreat Meeting for March 8, 2023 at 5:00 PM in the Milledgeville School Library. Voice vote showed 7 ayes and no nays. Motion carried.

NEW BUSINESS

Fiscal 2024 Budget: A motion was made by M. Urish and seconded by A. Drinkall to authorize Superintendent Tim J. Schurman to begin work on the Fiscal 2024 budget. Roll call vote showed S. Baylor-Schmidt, M. Bibler, A. Drinkall, P. Eubanks, T. Hackbarth, B. Smith, and M. Urish voting aye. No nays. Motion carried.

Approve Certified Staff RIF List: A motion was made by B. Smith and seconded by T. Hackbarth to approve the Certified Staff RIF List. Voice vote showed 7 ayes and no nays. Motion carried.

Superintendent Schurman reported that this is an annual requirement that we review and approve this list. If we were reducing staff we would use this list to determine who has the least seniority in each rating level.

Approve Asbestos Tile Removal Proposal: A motion was made by T. Hackbarth and seconded by M. Bibler to approve the asbestos tile removal proposal from Ideal Environmental. Roll call vote showed S. Baylor-Schmidt, M. Bibler, A. Drinkall, P. Eubanks, T. Hackbarth, B. Smith, and M. Urish voting aye. No nays. Motion carried. The work includes removal of asbestos tile in the FACS Room, Room 214, 215, and 216 at Milledgeville School. The work would be done this coming summer.

Approve ComEd Energy Efficiency Grant: A motion was made by A. Drinkall and seconded by M. Urish to approve the ComEd Energy Efficiency Grant. Voice vote showed 7 ayes and no nays. Motion carried.

This grant will provide \$132,000 in new or retrofitted LED light fixtures in the Milledgeville School. The new lighting should save the district nearly \$21,000/year in energy cost savings.
