**Spectator Attendance at Athletic Events:**

- 4 adults (plus siblings) for home athletes at RHHS
- 2 adults per visiting team athletes at RHHS
- General Rule - 150 spectators as a "cap guideline" at RHHS
- 2 adults (plus siblings) for home athletes at GMS
- Ice Hockey - spectators will be subject to arena policy
- Masks required for all spectators
- Subject to change based on public health situation.

**Late Arrival & Early Dismissal Permissions:**

No changes. Students at RHHS may take advantage of late arrival and early dismissal (with approval), but may not leave in the middle of the day and return to school.

**8<sup>th</sup> Grade Orientation to Rocky Hill High School:**

Schedule in-person orientation for 8<sup>th</sup> graders and their parents. Proposed date on January 24, 2022. Subject to change based on public health situation.
