This Contract applies to any enhancements or improvements to which Gadsden County Schools may be entitled. This pursuant to the price terms described below. The provisions of the Contract include:

#### **RouteBuilder Service Use Agreement**

Transfinder, a New York business, leases its GPS hand held units to assist in its RouteBuilder Implementation Service under the following terms. Please review carefully before making an order. "We" or "us" refers to Transfinder; "you" or "your" refers to service receiver.

- 1. Equipment: You receive GPS handheld unit(s) from us as determined in the implementation schedule.
- 2. Capture Start Date: The capture start date will be the date specified in the implementation schedule or the actual delivery date, whichever is later. We will try to provide the unit to you at least one day prior to start day; however, because of shipping and delivery limitations, the start date must be a business day. If you need the unit for a weekend departure, use the preceding business day as the start date.
- 3. **Capture Period:** The standard route capture period is 3 weeks. Once the 3-week period has expired, the units must be returned via authorized carrier. The shipping instructions will be included when delivering the unit. If the GPS units are not returned in this timeframe, the standard service cost of \$150/day/unit may be billed to you.
- 4. Use of Equipment: You agree to use the unit in accordance with the manual and other instructions, and to protect the unit against undue or unusual wear and tear. You will use the unit in a careful and proper manner and will not permit the unit to be operated or used in violation of any applicable federal, state, or local statute, ordinance, rule, or regulation. You agree to reimburse us for all damages to the unit arising from any misuse or negligent act by you, your employees, and agents. You will indemnify and hold our company harmless from any liabilities, forfeitures, or penalties for violations of any federal, state, or local statute, rule, or regulation.
- 5. Loss or Damage: In the event of the loss or destruction of the unit, you must report the loss or destruction immediately and are responsible to pay the fair market price of \$300.
- 6. **Ownership:** The GPS units remain Transfinder's sole property. You will inform us of the location of the unit upon request. All additions to, and all applications and information installed on any surrendered unit, will be deemed to be part of the unit, and we may delete, destroy, or otherwise dispose of such additions and applications without notice to you. Transfinder is willing to provide proposals for hardwired GPS units from one of our hardware vendors should you decide on a more permanent GPS solution.
- 7. **Returned Units:** You must obtain a Returned Materials Authorization ("RMA") from us before returning the unit for any reason. We will pay for the shipping of units returned at the end of the lease. You must keep the original packaging for the unit and return the unit only in its original packaging, with all accessories and documentation included.
- Indemnification: You will indemnify, defend, and hold harmless our company, our agents, partners, and employees from all claims, loss, or damage to our company on account of your possession and use of the unit(s).
- 9. **Remedies:** In the event of your breach of this agreement, we may (a) terminate the agreement and your rights under the agreement; (b) declare the total balance of all unpaid lease charges and/or the cost of purchasing the unit by you to be due and owing immediately; and (c) repossess the unit in entirety.
- 10. Separation: If any provision of this Agreement is found invalid, the remainder of the Agreement will still be valid.

#### II. <u>RESPONSIBILITIES</u>

**Data Conversion** - Gadsden County Schools will assist Transfinder in acquiring all the required student and school information for the Routefinder *Pro* system. The data must be provided in required ASCII or DBF file format and/or Gadsden County Schools will enter the data manually. Transfinder will convert the student and school data to the Routefinder *Pro* system format.

<u>County Map(s)</u> - Transfinder will convert a compatible GIS map(s) provided by the Licensee, or will provide commercially available map data as stated in Section I of this agreement.

**Installation** - Transfinder will provide Licensee with an installation CD and instructions for installation and will be available remotely during a mutually agreeable time to assist the Licensee with installing Routefinder *Pro* with: map(s) and student data from the initial download and conversion on licensee owned computer hardware (see appendix for specifications descriptions).

<u>Training</u> - Transfinder will provide system training as stated in Section I of this agreement. Additional Training may be purchased.

<u>**Remote Connectivity</u>** – Licensee must have a high-speed Internet connection and agrees to permit Transfinder Corporation to connect remotely to Licensee's computers and network for online training, support and software installation. Transfinder will connect to Licensee's computer(s) using secure remote desktop sharing technologies.</u>

<u>System Maintenance</u> - Transfinder will provide on-line remote support, unlimited telephone support, updates, and revisions. In order to manage any changes in pupil transportation, Transfinder will upgrade Routefinder *Pro* on a consistent basis to satisfy the growing demands of pupil transportation. Installation, as defined here includes loading Routefinder *Pro* files, and map(s) files required to support the licensee's area, and student data resulting from the initial download and data conversion.

The System Maintenance Fee (technical support & updates) for Routefinder *Pro* is free for the first year. On the anniversary date of the initial installation, the amount of **\$3,000.00 with Option "A" or \$4,200.00 with Option "B"** is due and every year thereafter (annual support fee prices are subject to change). The annual date will be calculated from the initial installation date of Transfinder Software. Transfinder will continue to provide technical support and system updates to the Licensee as long as the annual fees are paid and kept current.

Expenses for travel and living are not included in the initial cost, they will be billed to Gadsden County Schools at cost as incurred. Any Federal and/or State Sales or local taxes are the responsibility of the Licensee. The Licensee acknowledges the responsibility by signing this contact. All invoices will be paid, by or on behalf of, Gadsden County Schools within (30) thirty-days.

#### IV. LATE PAYMENT

If any valid invoice rendered by Transfinder is not paid when due, in addition to such other rights, Transfinder shall reserve the right to, without limitation, suspend updates, maintenance, support services and consulting, training and implementation services.

#### V. LICENSE AGREEMENT

**Grant of License:** Transfinder grants you a non-exclusive, non-transferable license to use Routefinder Pro, and the accompanying documentation. Each Routefinder Pro system may be installed only on the hard drive of a single-user, stand-alone computer. Transfinder retains the title to Routefinder Pro and related materials. You agree to protect Routefinder Pro from unauthorized use, duplication, reproduction, distribution, or publication. In addition, you will not allow any person, company, organization, or other entity to have access to Routefinder Pro and related materials. Transfinder reserves all rights not specifically granted in this license. Routefinder Pro is a © copyright of Transfinder. All rights reserved.

<u>General Terms</u>: Only a written agreement authorized by both the Licensee, and Transfinder's President/CEO, shall constitute a warranty or increase the scope of this warranty. This warranty gives you specific legal rights. You may have other rights, which vary from state to state. This Limited Warranty is governed by the laws of the State of New York and shall benefit Transfinder its successors and assignees.

#### VI. LIMITED WARRANTY

<u>Covering Routefinder Pro Sale of Software</u>: Routefinder Pro is a customized product. Transfinder warrants the training and technical services will be provided in good and workman like manner. Furthermore, Transfinder guarantees that the software sold will be free of gross negligence. You assume the entire risk as to the results and performance of the Software. The software has not been sold on a trial basis, and the Licensee acknowledges that it has seen a demonstration and had ample opportunity to view the product in operation using Transfinder's reference list, which has been provided. Neither Transfinder nor anyone else who has been involved in the creation, production, or delivery of this product shall be liable for any direct, indirect, consequential, or incidental damages (including damages for loss of business profits, business interruption, loss of business information, and the like)

<u>Severability</u>: If any provision or portion thereof of this Contract is invalid under any applicable statute or rule of law it is so to that extent to be deemed omitted from this Contract and with the balance of the Contract remaining in full force and effect.

**Jurisdiction:** This is a New York Contract to be interpreted under the laws of New York. The parties agree that all disputes arising under this Contract that cannot be settled between the parties shall be resolved in the courts located in New York. This Contract represents our entire understanding and agreement between the parties regarding the

Routefinder Pro system and supersedes any prior purchase order, communications, advertising, or presentations. This license may not be changed verbally, but only by agreement in writing, signed by authorized representatives of both parties. If any provisions of this Contract shall be unlawful, void, or for any reason unenforceable, it shall be deemed severable from, and shall in no way affect the validity or enforceability of the remaining provisions of the Contract. This Contract will be governed by the laws of the State of New York and shall benefit Transfinder, its successors and assignees.
