

GATEWAY OPENS EARLY HEAD START **CENTER IN PHILADELPHIA**



Gateway welcomed families and partners to a ribbon-cutting for the new Gateway Early Head Start Infant-Toddler Learning Center on 5th Street in Philadelphia in October. The building features five colorful classrooms filled with educational materials and hands-on activities to aid in child development. The center will allow 40 children to enroll and receive Early Head Start services.

Located at the Roberto Clemente Homes, the new center is the result of a long-time partnership with Esperanza. After a Nor'easter storm rendered the previous Early Head Start center in the area uninhabitable in 2018, this partnership came to life and allowed for the creation of this beacon of hope for the Philadelphia community.

The event featured walkthroughs of the classrooms, pumpkin painting and fall activities for the children, and tables with resources and referrals provided by our partners for families in attendance. Edward Bethea, CCAP, Gateway's Executive VP and COO, cut the ribbon with other dignitaries, officially opening the center.

"This has been a long time coming, but we are here, finally. We are very proud and pleased," said Bethea. "When you go inside and see what the five classes look like, I think you will agree that it was definitely worth the effort and the wait."

GATEWAY CAP WELLNESS CENTER EXPANDS TO MULTIPLE COUNTIES

As a response to COVID-19, Gateway Community Action Partnership provided aid to assist with the mental health crisis impacting communities across New Jersey due to the pandemic by opening its first mental and behavioral health facility, Gateway CAP Wellness Center. The Wellness Center has been in operation for three years to date, led by Mental Health Director and Licensed Professional Counselor, Ashlee Todd. Starting as a small therapeutic space at Gateway's central office, Gateway CAP Wellness Center has expanded to providing in-person services at two stand-alone locations in Cumberland and Salem counties, and telehealth services to communities throughout the state.



Gateway CAP Wellness Center provides community-based treatment and supportive services to individuals and families. The Wellness Center's mission is to ensure community-wide access to

services that promote health and wellness. The team of 20 mental health professionals is made up of culturally competent and diverse clinicians. Services at the Wellness Center are designed to provide residents with holistic approaches and evidenced-based interventions to address assessed community needs. Gateway CAP Wellness Center continues to expand its programming with the goal of providing services to underserved and marginalized communities, as well as areas in need of resources for mental and behavioral healthcare. Gateway CAP Wellness Center is presently preparing a satellite office in Passaic County, which is scheduled to open in March 2024.



SOUTHEAST GATEWAY MURAL ENHANCES **REVITALIZATION PLAN**

Southeast Gateway celebrated the completion of another successful neighborhood revitalization proj ect, a new mural on Terrace and Spruce Streets in Bridgeton, with a ribbon cutting ceremony held ir November. Albert B. Kelly, CCAP, Gateway's President and CEO, opened the ceremony with gratifying remarks addressed to Gateway staff members and partners who worked tirelessly to plan and complete the mural.
