Northerly approximately 700 feet along Havens Road; thence,

Southwesterly approximately 1 mile from Havens Road to an unnamed water feature; thence,

Southwesterly approximately 0.8 miles along said unnamed water feature to Middle Potlatch Creek; thence,

Northwesterly along Middle Potlatch Creek to the School District Boundary; thence,

Southerly along the Nez Perce-Clearwater County Line to the southwest corner of Section 34, Township 38 North, Range 1 West, Boise Meridian and the South School District Boundary; thence,

Easterly then Northerly then Westerly along the School District Boundary to Little Bear Creek; thence, departing from said School District Boundary

Northwesterly approximately 0.1 miles along Little Bear Creek; thence,

Southwesterly approximately 1.4 miles following no distinguishable geographic features to the north section line of Section 16, Township 38 North, Range 3 West, Boise Meridian, thence;

Westerly along said north section line to US Highway 99; thence,

BEGINNING at the intersection of the Wauncher Gulch Road (Southwick Road) and the Latah-Nez Perce County Line; thence,

Northeasterly then Easterly along said Latah-Nez Perce County Line to the Nez Perce-Clearwater County Line; thence,

Southerly along the Nez Perce-Clearwater County Line to the southwest corner of Section 34, Township 38 North, Range 1 West, Boise Meridian and the South School District Boundary; thence,

Westerly along said South School District Boundary to the Latah-Nez Perce County line; thence, departing from said School District Boundary

Northeasterly approximately 2.2 miles along said Latah-Nez Perce County Line to a point which is approximately 400 feet north of the south Section line of Section 34, Township 38 North, Range 3 West, Boise Meridian; thence,

Northwest to Highway 3; thence,

Northeast approximately 0.6 miles along said Highway 3; thence,

Southeast to a point on the Latah-Nez Perce County line, said point also being on the west section line of Section 35, Township 38 North, Range 3 West, Boise Meridian; thence,
