Board Member Appreciation Month

To the unsung heroes that serve our students, staff, and community of the Rainier School District, thank you.

Discussion: Study out on masks and length of time. A board member heard on the news that a cloth mask is about 30 minutes, surgical is an hour and a KN95 is 25 hours. Could we check the validity of this? Dr. Hattrick will look into it. A board member has been on campus multiple times and sees students not wearing masks, not following mandates. In the last week and half 3 Portland Schools have shut down. How are we looking? If we have to go back to virtual, how does that affect our grants? Mindset of, got vaccinated, I got my booster, when is this going to end? Virtual learning does not work.

Dr. Hattrick: Remind and Re-educate. For blatant refusal, we need to be looking at other options. This is a team and community approach, self-policing, self-monitoring. We're in this together. We will continue to work on this. Unfortunately everything is an option and we may have no control over what happens. Financially I do not think it will have a huge impact. We learned a lot last year.
