Parent and Family Engagement Policy

The Crazy Horse School agrees to implement the following statutory requirements:

- 2. The importance of communication between teachers and parents in an ongoing basis will be addressed through, at a minimum—

 - (B) frequent reports to parents on their children's progress;

- 1. Crazy Horse School will take the following actions to involve parents in the joint development of its school parental involvement plan under section 1116 of the ESSA: Also establish objectives and expectations for meaningful parent and family involvement.

 - Information shared on the school website, through NASIS messenger and Channel 92.
 - Staff will be available to parents to contact or ask questions.
- 6. Crazy Horse School will provide each parent and family individual student reports regarding the performance of their child on the State assessment in at least math, language arts and reading by:
 - Parents will receive reports on their child's educational progress.
 - The school will share the individual student reports that they receive from the assessment reporting agencies, along with a copy going into student files.
- 7. Crazy Horse School will notify parents that they may request, and the school will provide certain information regarding the professional qualifications of the student's teachers and paraprofessionals, as appropriate.
 - Parents will be notified if there is a conflict in the licensure and credentials of the staff providing the educational instruction of their child.
 - Licensure information for instructional staff is monitored and uploaded into the Native Star school reporting program.
- 8. Crazy Horse School will provide assistance to parents of children served by the school, as appropriate, by sharing information regarding:
 - the state's academic content standards.
 - the state's student academic achievement standards,
 - the state and local academic assessments including alternate assessments,
 - the requirements of Part A.
 - how to monitor their child's progress.

Staff will be provided with appropriate staff development and training to be able to provide quality instruction of state content standards through curriculum, instruction, and assessment. Student progress will be monitored and used in educational decision making for student success and decisions related to preparing students for Career and College Readiness.

Crazy Horse School will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to encourage parental involvement, by:

- Monthly parent nights
- Quarterly (minimum student-parent-teacher nights)
- Sharing information to parents and partnering with hem in student education
- 9. Crazy Horse School will, with the assistance of its parents, educate its teachers, pupil services personnel, principals, and other staff in how to reach out to, communicate with, and work with parents as equal partners in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by:

- Sharing of training information to parents
- Providing parenting and other requested trainings
- Discussions with parents to get input and suggestions to support student educational achievement
- 10. Crazy Horse School will, to the extent feasible and appropriate, coordinate and integrate parental and family involvement programs and activities with Head Start Programs and Oglala Lakota College Day Care Program. The school will also conduct other activities that encourage and support parents in more fully participating in the education of their children, by:
 - Creating a Parent Partnership Team consisting of (parents of students and staff)
 - The team will promote communication, activities, and efforts to increase student mastery
 of state content standards and toward student career and college readiness.
- 11. Crazy Horse School will take the following actions to ensure that information related to the school and parent-programs, meetings, and other activities is sent to parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand:
 - Multiple methods of communication will be used to include messages, texts, NASIS messenger, phone calls, letters, emails, CHS website, NASIS, social media.
 - Individual and group meetings, with use of translators as needed.
