The retreat for the CHS Staff was thoroughly enjoyed by all and had a great time during the 2 days of the retreat. Elementary drum group is doing a great job in the morning to start the day. The Home School Liaison is checking on student attendance and getting letters out for absences on 2-5-7 and 10 days.

Jodi Stoddard, School Improvement and Student Success Director, stated they are looking for options for bringing in additional licensed counselors. They also have 2 social worker positions and a Student Employee Assistant Program Coordinator position open. The visit to Huron's SDIEA Youth Day was a success with 3 students filling out applications and 1 student filling out an application to Creighton University. The BARR program has been going great, with staff meetings weekly. The BARR staff have completed 2 onsite visits to the school. NHS is hosting a toy drive and fund raising.
