



**School Parent and Family Engagement Policy**

In support of strengthening student academic achievement, Tattnall County High School receives Title I, Part A funds and therefore must jointly develop with, agree on with, and distribute to parents and family members of participating children a written parent and family engagement policy that contains information required by section 1116(b) and (c) of the Every Student Succeeds Act (ESSA). **JOINTLY DEVELOPED**

**Tattnall County High School** will take the following actions to involve parents in an organized, ongoing, and timely manner in the planning, review, and improvement of Title I programs, including opportunities for regular meetings, if requested by parents, to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their child and respond to any such suggestions as soon as practicably possible.

- An annual parent survey is conducted each year in order to gain input from parents on all parts of our parent and family engagement programming, including this parent and family engagement policy.
- An annual stakeholder feedback meeting is held each year in the spring in order to gain input from parents on the revision of this policy for the upcoming year.

- Tattnall County High School provides parents the Parent and Family Engagement Policy, School-parent Compact, Schoolwide Plan and the Title I Survey and Results in a meeting with request for input in the spring. ## **ANNUAL TITLE I MEETING**

**Tattnall County High School** will take the following actions to conduct an annual meeting, at a convenient time, and encourage and invite all parents of participating children to attend to inform them about the school's Title I program, the nature of the Title I program, the parents' requirements, the school parent and family engagement policy, the schoolwide plan, and the school-parent compact.

- Tattnall County High School will conduct an Annual Title I Parent Meeting in the fall of the year at a convenient time prior to November 1. All parents and families are invited and encouraged to attend where Title I information, school programs, and the parents' rights under Title I is shared with them.
- The Annual Title I Parent meeting will be posted on the school marquee, school website, school social media Facebook, as well as written notification sent home to families.
- A sign in sheet with roles, agenda, presentation and minutes will be kept by the Academic Coach as evidence of the meeting.
- The school Parent and Family Engagement Policy, Schoolwide Plan, and School-Parent Compact are available to parents, families, and other stakeholders.

## **COMMUNICATIONS**

**Tattnall County High School** will take the following actions to provide parents of participating children the following:

- Tattnall County High School prioritizes communication with students, parents and other stakeholders. Two-way communication between families and schools is necessary for student academic success. The school's parent and family engagement policy will be distributed to parents prior to November 1, sent home, posted on the school website and printed copies are available upon request at any time.
- The school will communicate with parents in multiple ways throughout the school year through Remind, social media Facebook, school marquee, parent portal, parent-teacher conferences, notices/notes/letters/flyers, phone calls, emails/texts, newsletters, Annual Title I Parent meeting, 504/EIP/IEP/TPC/ESOL/PAC meetings, open house/orientation, academic/grade level events, PTO meetings, registration nights, Google Classroom, automatic dialer, and annual CNA meeting.
- Parents may request a meeting at any time to discuss their child's progress. Parent conferences are encouraged to foster parent engagement in the education of their child.

- Communications will be translated into an understandable language that the parents can understand, to the extent practicable through Google Translate, Microsoft Translate, and translator as needed.

## **SCHOOL-PARENT COMPACT**

## **RESERVATION OF FUNDS**

During the Annual Title I Parent Meeting, the school shares ways that the funds have been spent including Parent Institute newsletters, student handbooks, Remind, agendas and supplies for parent and family engagement meetings.

## **COORDINATION OF SERVICES**

**Tattnall County High School** will, to the extent feasible and appropriate, coordinate and integrate parent and family engagement programs and activities with other Federal, State, and local programs, including public preschool programs, and conduct other activities, such as parent

resource centers, that encourage and support parents in more fully participating in the education of their children by:

- District Family Engagement Coordinator communicates and collaborates with local Head Start Programs throughout the year to ensure families are aware of enrollment dates and requirements.
- District Family Engagement Coordinator also shares Kindergarten registration information at Family Connection meetings and upon request from community partners.
- The school counselor serves as a resource for parents to obtain literature on hygiene, bullying nutrition, and other pertinent topics.
- Transition parent meetings are held for Pre-K families transitioning to kindergarten in the spring.
- Tattnall County High School coordinates a 9<sup>th</sup> Grade First for the upcoming 9<sup>th</sup> graders and their families to help them transition from the middle school to the high school in July.
- Tattnall County High School collaborates with businesses to provide resources for work-based learning meetings for parents and students.
- Tattnall County High School collaborates with colleges to provide resources for dual enrollment parent meetings.

## **BUILDING CAPACITY OF PARENTS**

**Tattnall County High School** will build the parents' capacity for strong parent and family engagement to ensure effective involvement of parents and to support a partnership among the school and the community to improve student academic achievement through the following:

- Providing parents with a description and explanation of the curriculum in use at the school, the forms of academic assessments used to measure student progress, and the achievement levels of the challenging State academic standards; and
- Materials and training to help parents to work with their child to improve their child's achievement, such as literacy training and using technology (including education about the harms of copyright piracy), as appropriate, to foster parent and family engagement
- Providing assistance to parents of participating children, as appropriate, in understanding topics such as the following:

  - Tattnall County High School provides parents with a description and explanation of the curriculum and assessments in use at the school as well as individual student academic assessment results and interpretation of the results, Title I, Part A requirements, and parent materials and training to support their child's academic progress through multiple participation

opportunities. These opportunities include parent and teacher conferences, RtI/504/IEP parent meetings, Annual Title I Parent Meeting, open house, senior parent night, dual enrollment parent meeting, registration night, and transition meetings.

- Tattall County High School provides opportunities for the participation of parents with limited English proficiency. ESOL teachers are available to assist students and parents with limited English proficiency. Individual academic assessments and the interpretation of the results will be interpreted for parents in a language they can understand through the assistance of the ESOL teachers and translator as needed. The school also has a Migrant Student Service Provider (SSP).

### **BUILDING CAPACITY OF SCHOOL STAFF**

**Tattall County High School** will provide training to educate teachers, specialized instructional support personnel, principals, and other school leaders, and other staff, with the assistance of parents, in the value and utility of contributions of parents, and in how to reach out to, communicate with, and work with parents as equal partners, implement and coordinate parent programs, and build ties between parents and the school by:

- Building capacity of school staff in the value and utility of contributions of parents and in how to reach out to, communicate with, and work with parents as equal partners, implement and coordinate parent programs, and build ties between home and school will be provided by the academic coach through professional development, professional learning communities, and/or department level meetings.
- The school responds to parent requests for parent and family engagement activities from the spring survey.
- District Level Family Engagement Coordinator provides technical assistance to the school.
- The school ensures that school information and parent programs, meetings, and other activities will be sent to parents in a format and language that parents can understand to the extent practicable.

**Tattall County High School** will provide other reasonable support for parent and family engagement activities under Section 1116 as parents may request by:

**Tattnall County High School** will keep parents informed of school activities by using multiple means of communication. Parents will be provided education tips and modeling to help their child at home with academics such as literacy, math, science, social studies, technology, GMAS assessment, dual enrollment, and others.

- Provide necessary literacy training for parents from Title I, Part A funds if the school has exhausted all other reasonably available sources of funding for that training.
