Roosevelt Public School District Parent-Student IPAD Use Contract 2023~2024

RESPONSIBLE USE

Student must sign out IPAD for use **in SCHOOL only**, on sign out sheet by IPAD lab. Sign out sheet consists of students name and number of IPAD. IPADS must be returned by the end of the class period signed out in.

Statement of Responsibility:

- The user is responsible for what he/she says and does on the network. Communication with thousands of others is quick and easy; therefore, it is important for the user to stop and think before communicating and to show respect for other people and for their ideas.
- Student users should assume that none of their data is private or confidential. Any communication or data may be subject to review by teachers, network, or school administration. Please remember that you are using a ROOSEVELT issued device and it should be treated as such!

Inappropriate Content:

- Students are not allowed to access, view, and or store inappropriate content or materials on Roosevelt IPADS
- Presence of weapons, pornographic materials, inappropriate language, threatening language, alcohol, drug, gang related symbols, or pictures will result in disciplinary action.
- All activity on the IPADS and any RPS issued email account, whether conducted at school or offsite, is subject to search as district property.

Legal Propriety:

- All IPAD users must comply with trademark and copyright laws and all license agreements. Ignorance of the law is no excuse for violations of such laws or agreements. If you are unsure, ask your classroom/homeroom teacher.
- Plagiarism is a violation of the rules. Give credit to all sources used, whether quoted or summarized. This includes all forms of media on the internet, such as graphics, movies, music, and text.
- Illegal downloading and distribution of copyrighted works are serious offenses that carry with them the risk of substantial monetary damages and, in some cases, criminal prosecution.

Unauthorized Access:

• Access to another person's account or without their consent or knowledge is considered hacking and is unacceptable.

Music, Video Games, or Programs:

- Music, videos, and games may not be downloaded or streamed over the Internet. This may be a violation of copyright law.
- All software/apps must be provided by RPS.
- Data storage will be through apps on the IPADS (Google Drive).
- Internet games are not allowed on the RPS IPADS.

Student Responsibilities:

- Use computers/devices in a responsible and ethical manner.
- Obey general school rules concerning behavior and communication that apply to network use according to Technology Policy.
- Keep passwords private. Should your password become compromised, contact the technology coordinator as soon as possible to change your password.
- Students should turn off and secure their device after they are done working to protect their work and information.
- If a student should receive email or other electronic messages containing inappropriate or abusive language or if the subject matter is questionable, he/she should contact a teacher.

DEVICE LOSS, DAMAGE, OR MALFUNCTION

Devices that malfunction or are damaged must be reported to RPS. The school district will be responsible for repairing devices that malfunction; however, the cost of repairs will be assessed as stated below.

Damage

• If a device is damaged (such as a cracked screen), the family of the student will be assessed a damage fee of up to \$150.

Intentional Damage

• If the school determines that intentional damage to a device has occurred, the family of the student will be responsible for up to the total cost of the device repair or replacement. The student may also be subjected to additional consequences.

Power Cords

• If a power cord is lost or damaged, a replacement fee of \$40 will be assessed.

Lost or Stolen:

• If a device is lost or stolen, the family of the student will be required to pay to replace the device.

Loss / Damage Payment

• In the event that a family is responsible for payment due to loss, theft or damage, a notice will be sent with a brief explanation and amount due. Payments should be made at the school office. Please keep this contract at home. Sign and return the last page to school.
