The open session was conducted in the Board of Education Room located at 210 North Street.

# **Preliminaries of the Meeting**

At 5:45 P.M., Board President Mr. Jason Heany declared a quorum and called the meeting to order.

### **Tax Rate Hearing**

At this time, Mr. Hunter proposed the district adopt the resolution authorizing the redemption of \$155,000 principal amount of general obligation bonds, series 2020 and authorize the publication of notice of redemption. This was advised by LJ Hart and Co. Mrs. Jennifer Pipal moved with a second by Mr. Andy Burkhart to accept the adoption of the resolution. Motion passed 5-0.

At this time, Mr. Hunter presented tax rate information and made his recommendation to approve the tax rate for the 2023-2024 Incidental Fund at \$2.75. Mr. Andy Burkhart moved with a second by Mrs. Jennifer Pipal to approve the tax rate at \$2.75 for the Incidental Fund. Motion passed 5-0.

At this time, Mr. Hunter presented tax rate information and made his recommendation to approve the tax rate for the 2023-2024 Debt Service Fund at \$0.5000. Mr. David Cooley moved with a second by Mrs. Jennifer Pipal to accept the tax rates as recommended. Motion passed 5-0. Total 2023-2024 Tax Levy Rate will be \$3.25.

The regular board meeting began at 6:00 PM. All in attendance recited the Pledge of Allegiance.

#### II Approval of Agenda

Mrs. Jennifer Pipal moved with a second by Mr. Jake Drenon to approve the agenda as presented. Motion passed 7-0.

## III Approval of Consent Agenda

Mr. Andy Burkhart moved with a second by Mrs. Jennifer Pipal to approve the consent agenda as presented - payment of bills for \$153,751.33 (check nos 1071; 148543-148632), open minutes from July 18, 2023, and financials. Motion passed 7-0.

# IV Administrative Reports

Mr. Wells, Mrs. Evan, and Mrs. Bowers were present for questions.

Mr. Hunter updated the board on the following items:

- A. Lead Water testing was completed on August 4th, 2023 with a 90% passing rate.
- B. New teachers will report to the district August 11, 2023 and all staff will be in the district on August 14, 2023.
- C. Open House is on August 17, 2023 Elementary School 5-7 PM, High School 6-8 PM.
- D. First day of school is August 22, 2023.

#### **V** New Business

- **A.** Mr. Hunter presented the following bids for Speech Services for the 2023/2024 school year:
  - a. ProCare Therapy (Mallory Pritzel) \$87/hour with a minimum of 30 hours.
  - b. Compass Therapy Solutions virtual SLP \$77/hour; in person \$82/hour or SLP-A virtual \$64.00; in person \$69/hour.
- Mr. Hunter recommended the board approve the bid from ProCare Therapy for the 2023/2024 school year. Mrs. Jennifer Pipal moved with a second by Mr. Jake Drenon to approve the bid from ProCare Therapy. Motion passed 7-0.
- **B.** Mr. Hunter presented a bid from Tigris Speciality Construction for the removal and installation of gutters and downspouts for the High School Builiding, totaling \$27,670.00. Fund 4 monies will be used to complete this repair. Mr. Jake Drenon moved with a second by Mr. Andy Burkhart to approve the bid from Tigris Speciality Construction. Motion passed 7-0.
- **C.** Mr. Hunter presented the following bids for WES and WHS tuck pointing:
  - a. MTS Contracting Inc Option 1 (\$11,700) HS gym south side tuck pointing; Option 2 (\$8,100) HS gym south side vertical caulking; Option 3 (\$18,550) Elem School front side tuck pointing; Option 4 (\$5,680) Elem School upper 3 walls tuck pointing; Option 5 (\$16,725) Elem School main entry caulking/painting; Option 6 (\$19,780) Elem School backside south wall painting.
  - b. MCR Mid-Continental Restoration Co. Inc.- High School (\$35,230); Elementary School (\$69,999).

Mr. Hunter recommended the board approve Options 1 - 6 from MTS Contracting Inc. for a total of \$80,535. Mr. Andy Burkhart moved with a

second by Mr. Jake Drenon to approve Options 1-6 from MTS Contracting Inc. Motion passed 7-0.
