6. SUPERINTENDENT DISCUSSION ITEMS:

A. Superintendent Update

The current enrollment is 13 students onsite and 11 students in the Home School Program, for a total of 24 students. The base count should be 30 with attendance percentage factored in. The program will be revised to a Hybrid model inclusive of the Home School Program. It was noted that students must meet immunization requirements to attend onsite. Concerns regarding attendance were discussed, and emphasis was placed on the need to increase enrollment.

B. Literacy Coach and Reading Specialist Grant

The school received a literacy grant in the amount of \$450,000.00 to be allocated over four years. The grant is designated for literacy coaching and staff training. Administration is considering restructuring staffing by eliminating one aide position and opening two paraeducator positions at 6.0 hours per day, with a portion of the cost charged to the grant. In addition, the possibility of hiring a full-time teacher was discussed to provide support for home school students in reading. It was noted that all expenditures from the grant must strictly follow the intended use guidelines.

C. Radio advertising our homeschool program

We currently have a commercial advertising the school. This is currently airing on multiple radio stations to increase enrollment and strengthen community awareness.

7. COMMUNITY INPUT

It was noted by a community member, that the current books used in the Home School program provide questions and answers but do not include the steps needed to reach the solutions. Much of the instructional material for teachers is available online. The Superintendent/Principal will follow up with the Home School teacher regarding these concerns.

Additionally, a citizen requested advertising regarding school activities also. It was reported that a commercial advertising the school is currently airing on multiple radio stations to increase enrollment and strengthen community awareness.

It was reported that significant work has been completed in preparation for the Williams Act visit. However, the Facility Inspection Tool (FIT) was not completed last year.

2. Updated Substitute Pay Rate

Mr. Moore reported that he spoke with the Chief Business Officer (CBO) regarding the pay rate for certificated substitute teachers. The CBO indicated that no established rate currently exists. Mr. Moore recommended a Step 2 rate of \$200.00 per day for certificated substitutes.

Mr. Moore reported that the district would need to hire two paraprofessional positions. He noted that three hours of each position's pay would be funded through the Literacy Grant.

The cost for this service is \$5,000.00, which is anticipated to be funded through the Modernization Grant. Mr. Moore will serve as Project Manager and coordinate with Fred Consulting. Mr. Moore requested board approval of the contract.
