Upon a motion by John Wells and seconded by Parrish King, this was approved.

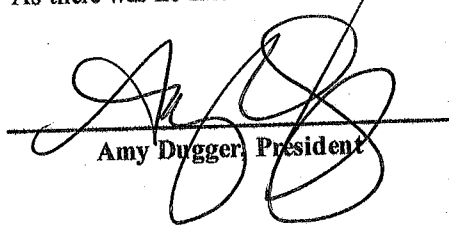
Consideration of School Handbooks Dr. Shakespeare recommended approval of the revised school handbooks for AES, AJHS, and AHS.

Review of TEAMS Portfolio Dr. Shakespeare presented the TEAMS portfolios for review.

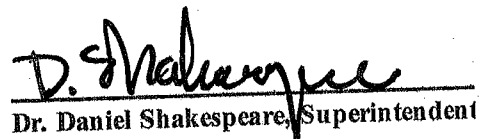
Review of AI Policy Dr. Shakespeare presented the AI Policy for review.
