WHEREAS, Asian Lunar New Year falls on January 29, 2025, during the 2024-2025 school year; and

WHEREAS, in consideration of New York State designating Asian Lunar New Year as a "school holiday", the District wishes to provide specific employees, not subject to a collective bargaining agreement, Asian Lunar New Year as a paid holiday for the 2024-2025 school year only; and

WHEREAS, the District hereby grants the following:

BE IT RESOLVED THAT in consideration of New York State designating Asian Lunar New Year as a State holiday, the Board of Education hereby grants and approves Asian Lunar New Year as a paid holiday for the Secretary to the Superintendent, the Business Manager/District Treasurer, and the Administrative Aide/Typist employed by the Minerva Central School District for the 2024-2025 school year only. As such, the Secretary to the Superintendent, Business Official and Payroll Clerk shall not report to work on January 29, 2025. This resolution shall be for the 2024-25 school year only, unless otherwise modified by the future action of the Board.
