Dear Delta Students and Families:

It's hard to believe we're in the final stretch of the school year! This letter is intended to inform everyone of some important end-of-the year graduation dates and information.

**Monday, June 3:** Special Schedule for Senior Picnic — All 11th graders (and seniors not attending the picnic) must attend our am session (8:30 - 11:30) - all 12th graders attending the senior picnic need to come for pm session only (12:30 - 3:30). Seniors (and graduating Juniors) wishing to attend the picnic, must return the permission slip enclosed in this mailer. If you are a mid-year graduate, you will need to arrive at Delta by 12:20 p.m. in order to ride the school bus to the picnic. All students attending the picnic must ride the bus and return on the bus. No driving yourself or early release before return. All students attending will return to Delta at 3:30 pm

**Tuesday, June 4: GRADUATION PRACTICE** - All graduates are to meet in the Ernest Righetti High School Gymnasium at 2:30 pm for mandatory practice. You must arrange your own transportation to ERHS. **IF YOU DON'T ATTEND PRACTICE, YOU WILL NOT PARTICIPATE IN THE GRADUATION CEREMONY.**

**Wednesday, June 5: GRADUATION** Delta High School's Commencement Ceremony will be held at 4:00 pm, at Ernest Righetti High School's Football Stadium. **Graduates are required to meet at the ERHS Gymnasium, no later than 2:45 pm.** All graduates will be checked by Security at the door before entering. Please be aware, students bringing weapons or illegal substances to graduation are subject detention/confiscation and will be prohibited from participating and will be released to a parent or law enforcement as necessary. Gates open at 3:00 pm for family and friend spectator seating, the processional starts at 3:30 pm, and the commencement should begin around 4:00 pm.

All students participating in the ceremony should dress appropriately for this celebration. Graduates may wear wedges or platform shoes; no stilettos or high heels are allowed on the field. Family provided leis, money necklaces, decorations, or stoles should only be worn after the graduation ceremony. No customization or decoration of the cap or gown is permitted. For the enjoyment of everyone in attendance, air horns, noisemakers, balloons or other distractions are not allowed in the stadium.

**Cap and Gown:** A cap and gown is required to participate in the ceremony. They're on sale now for \$40. They will be available for pickup after May 1. Please see the order form included in this mailer.

**Yearbooks:** A limited number of Yearbooks are available. The cost is \$20 through May or \$25 in June, Get yours today. When they're gone, they're gone. Yearbooks will be available for pick up the first week of June.

**Diploma Pickup and Textbook / Laptop Return:** If you have any textbooks from your previous school, they may be returned to Nicole in room 401 at any time. Laptops may be returned as well, but if you are still using your device, you may turn it in at the end of the school year. If you are unsure if you have any textbooks/devices checked out, please see or text Nicole to get confirmation at (805) 354-5406.

Diplomas will be available for pick up in the Delta parking lot, Thursday, June 6, from 9:00 am until 3:00 pm. All books and devices need to be returned and fees need to be paid before pick up. After June 6, Diplomas are available during school hours in the Delta Student Records Office.
