SCHOOL HEALTH SERVICES CONTRACT FOR SCHOOL YEAR 2017-2018

THIS AGREEMENT is entered into on this day of 4, 2017, between South Central Public Health District (hereinafter referred to as "SCPHD") and Dietrich School District #314 (hereinafter referred to as the "School District").

The parties to this Contract, in consideration of the mutual covenants and stipulations set out therein, agree as follows:

ARTICLE 1. SCOPE OF SERVICES

SCPHD will provide the following SCHOOL HEALTH SERVICES to the School District:

Annual consultation with the school superintendent and administrative staff early in the school year to establish school health services to be provided. Services shall include: 1) those services identified by SCPHD as being priority (e.g., communicable diseases, immunization, children with special needs) and 2) health services identified by the school district as being priority (e.g., vision and scoliosis screenings, 5th and 6th grade puberty classes). All services shall be provided within the constraints of contract hours.

- Assessment and referral of students who have identified health concerns with an 1. emphasis on communicable diseases.
- On-site and telephone consultations to coordinate the health care (case management) of 2. students with identified health needs and concerns.
- Coordination of vision and scoliosis screening activities including rescreens and referrals to appropriate community resources.
- The PHN will be available to provide programs to school staff and parents which are 4. focused on benefiting students (e.g., medication and health policies, parents as sexuality educators' seminars, etc.).
- The PHN will participate in evaluating school immunization levels and coordinating 5. appropriate follow-up.
- Educational programs will be presented within the classroom setting on topics identified 6. by the school and/or nursing staff.
- 7. The PHN will provide annual review of the health records of all students identified as having special health needs. This will include consultation with appropriate teachers, administrators, and parents to establish health care plans. The PHN will not provide direct patient care.





Idaho Public Health Districts

- In accordance with PL 94-142 and PL 99-457B, the PHN will participate in planning health care services to those handicapped students with identified special health care needs.
- 9. In conjunction with school personnel and local agencies, the PHN may coordinate the provision of school-linked clinics (e.g., immunization clinics).
- 10. The PHN will serve as a liaison person between school and local community agencies that provide <u>coordinated</u> health care, home visits and follow-up for identified students and their families.

School Services

(Services SCPHD will provide during 2017-2018 school year)

Care Plans: (These can take anywhere from 1-8 hours each)

- PCS/Medicaid (4-8 hours each)
- Individuals with Chronic conditions/illnesses monitored by physician (1-2 hours each)
- Chronic illness being treated with medications (2-3 hours each)

Communicable disease surveillance and consultation (30min to 1 hour each time)

Immunization status/ evaluation (30min to 1 hour, depending on need)

Vision Screening (K, 1st, 3rd, 5th)

- Full Screen (5-8 hours)
- Referrals (2-4 hours depending on how many referred by Lion's club)

Scoliosis screening (5th & 8th) 1-2 hours depending on class size

Puberty classes

- 4th hygiene only (1 hour per nurse, requires 1 nurse)
- 5th girls and boys separate- learn about own body (1 hour per nurse, requires 2 nurses)
- 6th girls and boys separate- learn about opposite sex (1 hour per nurse, requires 2 nurses)

Trainings (staff and/or parents) (1-2 hours depending on the need)

- Medication administration
- Treatment/Care of a chronic illness
- Epi Pen
