What is Title I?

Villa Rica Elementary is identified as a Title I school as part of the Every Student Succeeds Act (ESSA). Title I is designed to support State and local school reform efforts tied to the challenging State academic standards to improve teaching and learning for students. Title I programs must be based on effective means of improving student achievement and include strategies to support family engagement. All Title I schools must jointly develop with parents and family members a written parent and family engagement policy.

What is it?

This is a plan that describes how Villa Rica Elementary will provide opportunities to improve family engagement to support student learning. How is it revised?

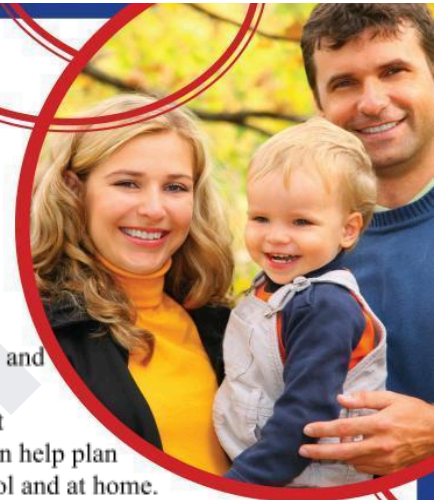
Villa Rica Elementary School invited all parents to attend our annual School Forum last spring to review and revise this parent and family engagement policy, as well as the schoolwide plan, our school-parent compact, 1% family engagement budget, ways to build staff capacity, and the school wide plan. Additionally, parent input and comments regarding this plan are welcome during the school year through an online form. The plan is posted on our school website for parents to view and submit feedback throughout the year. All parent feedback received during the year will be used to revise the plan for the next school year. We also distribute an annual survey online and by mail to ask parents for their suggestions on the plan and the use of funds for family engagement. Parents and family members can also give feedback during several parent meetings and activities during the school year. Who is it for?

All students participating in the Title I, Part A program, and their families are encouraged and invited to fully participate in the opportunities described in this plan. Villa Rica Elementary will provide full opportunity for the participation of parents and family members with limited English, with disabilities, and of migratory children.

2025-2026 District Goals

The percentage of students scoring at Proficient or above on the Georgia Milestone Assessment (GMAS) English Language Arts and on the Math End of Grade Assessments will increase by 3% points.

The percentage of students scoring at Proficient or above on the Georgia Milestone Assessment (GMAS) Mathematics End of Grade Assessment will increase by 3% points.

2025-2026 School Goals

On the 2026 GMAS, increase the students performance in reading and mathematics by 3 percent.

The focus for reading is:

K-1: Beginning sounds and blending

K-4: Vocabulary development

K-5: Increased rigor in reading passages

The focus for math is:

K-5: Number sense and fluency

School-Parent Compacts

As part of this plan, Villa Rica Elementary and our families will develop a school-parent compact, which is an agreement that parents, teachers, and students will develop that explains how parents and teachers will work together to make sure all our students reach grade-level standards. Villa Rica Elementary is Branching Out!

Villa Rica Elementary will take the following measures to promote and support parents and family members as an important foundation of the school in order to strengthen the school and reach our school goals. We will:

Ensure that all information related to school and parent programs, meetings, and other activities is published in both English and Spanish, posted on the school website, and included in the monthly school newsletter for all families.

Provide monthly trainings for staff during their planning periods on strategies to improve communication with parents and ideas to increase family engagement with reading and math activities for our students outside of the classroom. Staff will also share best practices during regularly scheduled faculty meetings.

Partner with early childhood programs, middle and high schools, college and career ready resources or organizations, parent resource centers, or other programs (as applicable) to help prepare parents and their children for successful school transitioning.

Share information in English and Spanish on the school website and in the school newsletter for parents to understand the school's academic standards and assessments as well as the ways parents can monitor their child's progress and work with educators.

Communicate with all families and the community on a regular basis regarding school wide events and activities, through phone messages, social media, and flyers.

Work with our parents to develop relevant trainings and helpful presentations to educate our staff on the importance of parent and family engagement and how to support student learning.

Provide necessary materials and handouts for parents at conferences, meetings, and activities to help parents work with their child to improve their child's achievement.

Use our Partners in Education and School-Community Team to improve awareness of the activities and events listed in the school parent and family engagement policy.

Offer literacy and computer classes for parents and family members to help further enhance their various educational levels.

Collect feedback from parents and family members at all events, place input cards around the building and post a suggestion form on the school website in order to respond to parents' requests for additional support for parent and family engagement activities.
