PROPERTY COMMITTEE

Renovations for the school-based health clinic for an amount of up to \$196,944, pending disclosure of three competitive bids, were unanimously approved as recommended by the committee.

The motion carried unanimously.

OPEN SESSION

The consensus of the Board was to default to the Georgia Code of Law governing school tribunals and honor the suggested consequence of the student tribunal appeal.
