The school provides information to parents to understand the requirements and opportunities of being a Title 1 school during the annual Title 1 Parent meeting. Parent resources in regard to the State's academic content standards and academic achievement standards are made available during Parenting Day, Academic Nights, Parent/Teacher conferences, the school website and the MCPSS website. Other opportunities to involve parents in the school partnership are through PTO meetings and committee meetings. Parent trainings are offered throughout the year as needed to keep parents up to date with the latest academic programs and technology. Parents work with teachers to support their children's learning utilizing 1:1 devices in class for all students and at home for third through fifth grade students. Technology training and feedback surveys will be utilized to involve parents in the development of our school's 1:1 device program.

The faculty and staff of Old Shell Road School recognize the value of parent involvement and contributions. The principal encourages parent involvement in all aspects of our school. Faculty meetings, committee meetings, and teacher representatives on PTO are utilized for collaboration and planning of opportunities for parent involvement and for improvement of the communication efforts between our parents and the school. Parent surveys are used to gather input and update the most effective means of communication between school and home and home and school. PTO meetings are also held monthly to give parents opportunities to stay involved throughout the year. Our school showcases our students during grade level performances throughout the year, and this offers an additional opportunity for parents to be involved in school activities through the arts.

The school provides information to English Language Learners' parents through translators or printed material in the home language when necessary. Old Shell Road Magnet School holds its annual Title 1 meeting for all parents during the first quarter of the school year. The annual meeting explains all required information related to participation as a Title 1 school (parental rights, school improvement plan, compacts, parent involvement, surveys, etc.). The Title 1 minimum parenting allocation requirement for our school is \$1, 789.48

Parent meetings are offered on a flexible schedule, during the day and at night, to provide opportunities for all parents to participate. Information is made available and communicated to parents who are not able to attend all meetings. Parent resources are available through a variety of avenues to reach all parents.
