- K. Approval of request from the Gifted Program for an overnight field trip to McDowell Environmental Center - Nauvoo, Alabama, March 18-20, 2024 for 50 students (3rd-8th grade), 10 chaperones. Students will reflect on field trip experiences by presenting information using technology, visuals and other creative resources that they would like to use. Cost/Source of Funds: Grant money will pay for all cost except for \$30.00, Student Fee/\$30.00 and donations from parents to cover the cost of students who cannot pay
- L. Approval of request to contract with HANDS a division of the Alabama Autism Assistance Program to conduct: functional behavior assessments, develop behavior intervention plans, provide applied behavior analysis therapy to students with IEPs, 504 Plans and PST Plans; and also train staff on behavior intervention plans. Contract effective October 1, 2023 to September 30, 2024. Board Certified Behavior Analyst (BCBA) Services are \$110.00/hr.; Registered Behavior Technician (RBT) \$50.00/hr.; mileage-.0655/mile or current state mileage rate. Source of Funds: Special Education VI-B Funds and ESSER III Funds
- M. Approval to contract with Mary-Margaret Newland, MS, CCS-SLP for speech and/or language evaluations in Spanish of preschool and/or school-aged children whose native language is Spanish. The evaluation is needed to determine eligibility for special education service. Cost: \$422.00 per evaluation per school-aged child; \$360.00 per evaluation per preschool-aged child. Contract cost is dependent on the number of students who need evaluations whose native language is Spanish. Source of Funds: Special Education VI-B and Preschool Funds
- N. Approval of request to contract with J.R. Moore and Associates to provide counseling services for 2023-2024 and 2024-2025 school years. The services will be provided to the general education students who are in need of counseling services/psychological evaluation from a mental health professional. Cost: Individual (TIER I, TIER 2 & TIER 3) Counseling: \$50/30 minute unit Group (TIER 1, TIER 2 & TIER 3) Counseling: \$150.00/60 minute unit Professional Teacher/Staff Development: \$150.00/60 minute unit On Call Crisis Intervention & Debriefing: \$50/30 minute unit School-wide Assembly Intervention: \$150/60 minute unit. The total amount rendered will be based on the number of students in need not to exceed \$50,000.00. Source of Funds: ESSER III
- O. Approval Of Positive Behavioral Interventions and Supports (PBIS) an evidence-based Alabama State Department of Education recommended program which includes training for the PBIS Leadership Team and ongoing coaching for seven schools (5 Elementary, Middle, and High School) for the 2023-2024 and 2024-2025 school years. The schools will have support to initiate and sustain their PBIS framework through monthly coaching sessions. During these sessions, PBIS staff will meet with administrators and PBIS Leadership Team to problem solve, analyze culture data, and assist with enhancing a positive school culture and climate throughout the elementary and secondary learning environment. Cost: \$24,750.00, Source of Funds: ESSER III
- P. Approval for Hope Institute to provide services to assist educators with the best practices for developing character within schools. The Hope Institute will provide Hope Academy for seven schools within the system for the 2023-2024 school year. Hope Academy consists of six professional learning sessions, collaboration on a school implementation plan, a starter library of character resources, peer networking among Alabama school leaders, consultations, and one Professional Learning Unit (PLU) or clock hour for educators who attend trainings and adhere to the required guidelines. Cost: 1st year in the program Jonesboro Elementary, Hard Elementary = \$5,000.00, 2nd Year in the Program Greenwood, BCMS, BCHS, Abrams, Westhills = \$3,000.00 per school, Total cost for all seven schools = \$25,000.000, Source of Funds: ESSER III.
- Q. Approval for Better Basics to provide Tier 3 intervention for math. Five elementary schools will receive 3 unites each. Cost: \$75,000.00 (5 x \$15,000.00 for each elementary school), Source of Funds: ESSER III
