Loudenslager Elementary School will ensure the learning environment is safe and conducive for students to engage in academic studies. To ensure high quality instruction, we will assure the instruction is aligned with the audited curriculum, establish continual data collection and analysis of student performance, regularly check teachers' lesson plans,

perform regular formal and informal walkthroughs and provide on-going feedback, support and relevant professional development for all staff members.

2. Hold parent-teacher conferences (at least annually in elementary schools) during which this compact will be discussed as it relates to the individual child's achievement. Specifically, those conferences will be held;

District scheduled parent conferences will be held on November 17th, 20th, and 21st of 2023, and February 1st and 2nd of 2024, however, a parent/teacher conference can be set up directly with your child's teacher at any point during the school year.

Parents have regular access to their child's grades and progress via the Genesis Parent Portal starting on Monday September 18, 2023 and will be updated weekly. All formal quarterly progress reports are available for parents to view on the following dates: October 6, 2023, December 15, 2023, March 1, 2024, and May 3, 2024. These reports will be available in the Genesis Parent Portal.

4. Provide parents reasonable access to staff. Specifically, staff will be available for consultation with parents as follows;

Parents can contact staff members via email as well as the school phone number and personal extension. Staff members are also available for an in-person meeting, at Loudenslager before and after school and during their assigned duty-free period each day. Teacher coverage can also be provided for a teacher to accommodate a parent's meeting availability.

5. Provide parents opportunities to volunteer and participate in their child's class, and to observe classroom activities, as follows;

Throughout the school year each grade level will have specific activities and events that will promote and encourage parental involvement including our One World Festival, Black History Month Celebration, Field Day Program, and Field Trips. Parents will be notified of these events by their child's teacher and will be encouraged to volunteer and support these programs.

Parent Responsibilities

We, as parents, will support our children's learning in the following ways:

- **Monitoring attendance.**
- **Making sure homework is completed when assigned.**
- **Promote a reasonable bedtime to ensure engagement at school.**
- **Monitoring the amount of television watched by my children.**

- **Promoting positive use of my child's extracurricular time.**
- **Staying informed about my child's education and communicating with the school by promptly reading all notices from the school or the school district, either received by my child or by mail, and responding, as appropriate.**

- **Serving, to the extent possible, on policy advisory groups, such as being the Title I, Part A parent representative on the school’s School Improvement Team, the Title I Policy Advisory Committee, the District wide Policy Advisory Council, the State’s Committee of Practitioners, the School Support Team or other school advisory or policy groups.**
