

TAX CREDIT ELIGIBILITY
LIMITS ARE BASED ON
FILING STATUS:

SINGLE INDIVIDUAL OR HEAD OF HOUSEHOLD: UP TO \$1,000 GA INCOME TAX CREDIT

MARRIED COUPLE FILING
SEPARATELY: UP TO \$1,250 GA
INCOME TAX CREDIT

MARRIED COUPLE FILING JOINTLY: UP TO \$2,500 GA INCOME TAX CREDIT

S-CORPORATION SHAREHOLDER, LLC MEMBER OR PARTNERSHIP: UP TO \$10,000 GA INCOME TAX CREDIT

C-CORPORATION OR TRUST: UP TO 75% OF ANNUAL GA INCOME TAX LIABILITY

STEPS TO CONTRIBUTE TO THE
FANNIN COUNTY SCHOOL SYSTEM
THROUGH THE PEACH EDUCATION TAX CREDIT

- 1. APPLY NOW AT GFPE.ORG (IT TAKES LESS THAN 1 MINUTE TO COMPLETE YOUR APPLICATION!).
- 2. RECEIVE APPROVAL FOR THE TAX CREDIT AMOUNT YOU SUBMITTED, ALONG WITH A PAYMENT DEADLINE FROM GFPE. GFPE AND GA DEPT OF REVENUE WILL NOTIFY YOU WITH APPROVAL.
- 3. MAKE YOUR DONATION. SUBMIT YOUR PAYMENT TO GFPE BEFORE THE PAYMENT DEADLINE, WHICH IS 60 DAYS AFTER RECEIVING APPROVAL. YOU WILL BE ASKED TO DESIGNATE YOUR DONATION TO A PROJECT. PLEASE CHOOSE "FANNIN COUNTY SCHOOL SYSTEM."
- 4. CLAIM YOUR TAX CREDIT. TO CLAIM THE TAX
 CREDIT ON YOUR STATE INCOME TAXES, YOU WILL
 NEED TO COMPLETE FORM IT-QED-TP2 AND
 ATTACH IT TO YOUR INCOME TAX RETURN WHEN IT
 IS FILED. (NOTE: YOU WILL TAKE THE CREDIT WHEN
 YOU FILE YOUR TAXES IN THE YEAR FOLLOWING
 YOUR CONTRIBUTION).

REVENUE REQUIRES E-FILING FOR ALL TAX CREDIT FORMS.
