Education Report

Ms. Best read the Education Report.

1. Approve the appointment of Jon William Pollard as Acting Superintendent retroactive to June 7, 2022, until receipt of commission by the Commonwealth of Pennsylvania.
2. Approve the appointment of Jon William Pollard as Superintendent for a term of five years at a salary of \$119,000.00 as per terms of the contract.
3. Approve the appointment of Eric Speece as Secondary Center building principal at a salary of \$88,000.00.

Motion by Ms. Best, second by Mrs. Valenti, to accept the education report.

On the Question: Phil Campenni read the minutes of May 5th where as Dr. Pollard was appointed as Superintendent for a term of three years and Mr. Campenni read the board members votes. Mrs. Valenti responded that this was discussed to change it to five years and Mr. Campenni was present when this was discussed.

Melissa Dolman, teacher, asked if the position needed to be rescinded and voted on again. Attorney Ferentino responded this new act would override the previous one.
