

GATEWAY PARTNERS WITH KABOOM!, ATLANTIC CITY ELECTRIC, PAULSBORO TO CREATE CHILD-DESIGNED PLAYGROUND AS PART OF REVITALIZATION PLAN

More than 130 volunteers from Gateway Community Action Partnership, the Borough of Paulsboro, Atlantic City Electric, KABOOM!, and community residents came together to bring a child-designed playground to life at West Buck Street Park in April. Volunteers had only about 6 hours on this designated "Build Day" to assemble thousands of pounds of playground equipment, fill the space with 138 cubic yards of mulch, build picnic tables, paint a mural, and make sure everything was ready for the children to enjoy.

This playground build is the starting point of a longer-term revitalization plan for the Paulsboro community under Gateway's Neighborhood Revitalization Planning Grant, received in December 2023. It focuses on community-driven projects, like the playground build, to support comprehensive equity-focused community development plans.

The project is also part of a nationwide effort led by KABOOM! to end playspace inequity—the reality that far too many children and especially children of color do not get the chance to play on a playground in their community, something that should be part of every child's life. Their work ensures every child can experience the numerous physical, social and mental health benefits of play regardless of background or where they live.

ALBERT B. KELLY RECEIVES PRESTIGIOUS NATIONAL AWARD IN COMMUNITY ACTION

Albert B. Kelly, CCAP, Gateway's President, CEO, and founder, received the prestigious National Lyndon Baines Johnson Leadership Award at the National Community Action Partnership's Annual Convention on August 29 in Seattle.

Kelly accepted the award before more than 1,800 attendees at the convention's Awards Gala. With approximately 1,100 Community Action Agencies in the country, being selected for this award was highly competitive.

"It's not about me, it's about what we have done together at Gateway," Kelly said as he accepted the award. "In my time in Community Action. I thank the people who inspired me and helped me become the Lyndon Baines Johnson Award winner. I thank you very much. It's NCAP Board Member Dreama Padgett, an honor to accept this award among people who work so hard to make America a better place to live.

This award recognizes Community Action practitioners whose exper-

These practitioners have led their Community Action Agency in connecting numerous children and families to greater opportunities, transforming their lives and their communities. Albert B. Kelly's dedication to making communities better places to live has been manifested in numerous ways in his 37 years in Community Action, making him a deserving recipient of the National Lyndon Baines Johnson Leadership Award.

Earlier in the year, Kelly was recognized by Gateway staff for his 40 years of service to our communities.

GATEWAY A LEADER IN PROVIDING AFFORDABLE HOMES FOR FAMILIES

Gateway Community Action Partnership celebrated the groundbreaking of the Spruce Fields Homes Development in Bridgeton's Southeast Gateway (SEG) Neighborhood in October. This project marks the construction of five new residences aimed at improving the community's quality of life and promoting self-sufficiency.

Edward Bethea, CCAP, Executive Vice President and COO, welcomed attendees and recognized key contributors, including Gateway's Housing Director Jonathan Burdzy, consultant John Restrepo, Donovan Architects, and Nocentino Homes. Ivy Melendez, Executive Director of the Bridgeton Housing Authority, also spoke. Lorissa Luciani from the New Jersey Department of Community Affairs highlighted the impact of projects like Spruce Fields.

Albert B. Kelly, CCAP, Gateway's President and CEO, expressed gratitude for his team's efforts and detailed Gateway's \$200 million investment in housing since 1992. He emphasized the need for quality affordable housing in Bridgeton. Bethea announced that the Spruce

Fields homes will be completed in early 2025, with prices between \$100,000 and \$120.000. In another housing initiative, Gateway, as a partner with Eastern Pacific Development in the Phase II of the Phoenix Redevelopment Area Project in Bridgeton, led a groundbreaking ceremony in July. This initiative marks a significant step in affordable housing development, as it will provide fifty-six three-bedroom units. Thanks to the New Jersey Housing Mortgage Finance Agency (NJHMFA), financing and equity investment from TD Bank, and support from Enterprise Community Partners, this community project has come to fruition

Edward Bethea, CCAP, Executive Vice President and COO of Gateway Community Action Partnership, was elected Chairman of the Housing and Community Development Network of New Jersey (HCDNNJ). The HCDNNJ aims to promote balanced and equitable housing and community choices for NJ residents. Gateway's Women, Infants and Children's program marked the 50th Anniversary of WIC and World Breastfeeding Month with celebrations at their Camden, Atlantic City and Vineland locations. Health fairs, music, games, a bounce house, health screenings, food demonstrations, giveaways, refreshments, music and entertainment marked the events which were well attended by parents and children. Also attending were Gateway staff, including Edward Bethea, CCAP, Gateway's Executive Vice President/COO and Jaya Makukha, CCAP, Gateway Community Action Partnership's VP of WIC. Elected officials representing the residents of the locations attended, as well.




Funding Sources for Gateway Head Start
