The Board of Trustees of Florence County School District Five met for regular session on Monday, September 27, at 7:00 p.m. at Johnsonville Middle School Media Center.

- 1. **Call to Order, Welcome, and Pledge of Allegiance** Vice Chairman Truesdale called the meeting to order at 7:00 p.m. She welcomed those present and asked everyone to stand and join in the Pledge of Allegiance.
- Confirmation of Notice to Media Vice Chairman Truesdale stated that in accordance with the <u>South Carolina Code of Laws</u>, 1976, as amended, Section 30-4-80(e), the following were notified of this meeting: *Morning News, NPO News*, WMBF-TV, WPDE-TV, and <u>www.fsd5.org</u>.
- 3. Approval of Agenda The Agenda was approved by general consent of the board.
- 4. **Public Forum** There was no one present to address the board in Public Forum.
- 5. **Consent Agenda** (A-C) Vice Chairman Truesdale reviewed the items of the Consent Agenda which included Board Minutes for August 23, 2021, and Monthly Financial Statement for August. All items passed by general consent of the board.

6. Regular Agenda

A. Superintendent's Report:

1. Operational Updates - Mrs. Prosser said a vaccination clinic was held on September 13th administered through Health Care Partners. She discussed recent Covid-19 guideline changes. Maintenance and safety walk throughs were conducted at all three schools last week with pending work orders being addressed. Mrs. Prosser said that ESSER 3 has been approved, and the spending plan will be posted on the district website.

- 2. Instructional Updates Mrs. Prosser discussed measures taken to help and support teachers during Covid-19. She said academic assistance is being offered through utilizing a learning liaison, tutoring, additional remediation resources, and behavioral assistance. In an afterschool update, Mrs. Prosser said the 21st Century Afterschool Program has 120 students participating and highlighted upcoming activities. She reminded the board that October 21st will be utilized as the first mock E-Learning day. Mrs. Prosser stated that administration is using Classroom Mosaic to document teacher observations. She reviewed MAP and School Report Card Scores and explained the John Maxwell Leadership Program at JMS.
- 3. Legislative Updates Mrs. Prosser gave an update on Act 44 (Revised Accountability for districts/dissolution of boards/intervention and assistance), Student Identification Card Suicide Prevention for grades 7-12, and Act 36 (Palmetto Fellows Scholarship).
- 4. Recognitions Mrs. Prosser recognized JMS Staff of the Month, Mrs. Elizabeth Pope and Mrs. Stephanie Carmichael. She also commended Mrs. Wendy Calcutt for receiving a Donor's Choose Grant for the JHS Media Center. Mrs. Snowden announced two recipients of Adult Education Diplomas, and Mrs. Prosser presented the diplomas on behalf of Florence County Adult Education. Ms. Brenda Hannah and Dr. Carol Hill were both present and gave positive support for both recipients. Principals and staff were given an opportunity to give school and department updates.

7. For Action Agenda

- A. SCSBA Delegate Assembly Vice Chairman Truesdale called for nominations for a voting delegate to the SCSBA Delegate Assembly in December. Mrs. Green moved that Mr. Richardson serve in this capacity, and Mrs. Green volunteered as the alternate, seconded by Mr. Timmons. There being no other nominations, the motion carried unanimously.
- B. Textbook Adoptions Mr. Gaster moved, seconded by Mr. Richardson, that the board approve the 2021 District Textbook Adoptions as presented by Mrs. Snowden. The motion carried unanimously. A discussion ensued. (Exhibit A)
- C. First Reading of the Following Policies:

 - 3. JICG (Tobacco Use by Students) Mr. Richardson moved, seconded by Mr. Timmons, that the board give First Reading to Policy JICG (Tobacco Use by Students). The motion carried unanimously.
- D. Second Reading of Policy Revision IKAA (Tests and Examinations) Mrs. Green moved, seconded by Mr. Richardson, that the board give Second Reading to Policy IKAA (Tests and Examinations). The motion carried unanimously.
