12. Update on a rchitectural firm to do a full schematic design on building for Quarterback Club.

Building is t eing designed by Summer Town Metals. Delivery of building will from 8 to 10 weeks from order date. 3ledsoe County Board of Education will pay for cost of drawing for the building. That amount will be \$1,250.00. Topographical survey will be completed by March 25, 2022 and site design by April 15, 2022

Site design will be for the Quarterback Club Building and re-grading of the softball field to address storm water issues with the field.

Mr. Allen Jones is the architect on this project.

13. Approval of a schematic design and proposal for Softball Building.

There are two proposed options for this building:

Option #1: Use the design drawings that were bid at an earlier date that came in over budget when a bid and incorporate subcontractors that are willing to provide their services for free or at a reduced rate. This building would qualify under the ESSER Grant guide ines and ESSER Grant funds could be used to fund this project Option #2: To break apart the design into two facilities. Use the subcontractors that are willing to provide free or reduced rate services to reduce cost.

This option vould not quality under the ESSER Grant so other funds would have to be used to fund.

After much discussion Mr. Farmer suggested the following:
Mr. Farmer stated that Mr. Allen Jones, Architect, should develop a set of bid packages for this building as drawn and try to reduce the cost to make it affordable. Breaking out the bid packets and releasing them for public bid and strongly encouraging individuals to bid and meet the standard bond requirements and bring it back to the Board as it was bid.

This will give the Board a realistic budget for this project in order to proceed.
