The committee will consider the personal essay, academics, extra-curricular activities, work experience, and community service.

To complete this application, you must email a resume, a transcript, a letter of recommendation from a school employee, and a personal essay on the topic: finding healing and hope in the midst of adversity. You may include a description/narration of the adverse situation, how you dealt with the issue, and how overcoming adversity will help you in the future. Please write the essay yourself.
