

Banking Investing and Insurance

Late/Make-up Work Policy

Late Work: Students may submit late work with a penalty of 10 points per day, with a cap on the assignment of 70%. This does not guarantee a grade of 70 after the work is evaluated.

Make-Up Work: It is the expectation of TCSD that all work missed due to any absence will be made-up. Some work by its very nature is impossible to make-up and may necessitate alternative assignments. The Principal or designee will be the final authority in determining alternative assignments. The responsibility for arranging to complete work missed is to be assumed by the student and parent/guardian in conjunction with the teacher. Make-up work is to be completed at the time specified by the teacher/Principal. The time limit is not to exceed 10 school days. Exceptions will be decided with input from the parent/guardian, student, teacher and Principal, with the Principal having the final decision.

Academic Honesty: The expectation of the Taliaferro County School is for all students to be honest and responsible. Cases of plagiarism and cheating will not be tolerated and will result in a grade of zero.

Assessments/Grading: Progress reports are issued every $4\frac{1}{2}$ weeks. Report cards will be sent out at the end of each 9-week marking period and at the end of the semester. There will be a variety of formative and summative assessments as well as a daily class participation grade.

Formative Assessments: 60%

(Daily work includes class work, warmups, class participation, and, quizzes.)

Summative Assessments: 40%

(Major work includes presentations, projects, and test.)
