Two of the texts have new versions coming out in January 2023. Would you accept PDF versions as a sample?	We will access PDF versions of new materials. Please send previous editions if there are similarities.
Can you please provide the course description for Grade 7 and Grade 8 Social Studies?	Grade 7 and 8 social studies should align to AZ Standards - <a href="https://www.azed.gov/sites/default/files/2019/06/6-8%20Grade%20Band%20Standards%20as%20a%20Glance%206.10.19.pdf?id=5d016dd21dcb250334288aae">https://www.azed.gov/sites/default/files/2019/06/6-8%20Grade%20Band%20Standards%20as%20a%20Glance%206.10.19.pdf?id=5d016dd21dcb250334288aae</a>
What format do the samples need to be in? Will you accept a pdf?	The preference is the bound textbook (student and teacher edition), but a PDF is acceptable.
On page 30, for the proposal requirements, do you want one (1) original, one (1) copy and one (1) USB?  Page 30 has <b>One (1) Original, one (7) marked "COPY"</b> (proposal only not samples) – <b>mailing label #2 (page 48), and one digital copy (USB Drive)</b> of your Proposal must be submitted.	There is a typo on page 30. There should be one (1) original, one (1) copy and one (1) USB.
Will you accept the same title for an on-level course and an honors course for submission?	The same title is acceptable. If there are supplementary materials for honors, please point to those. If there are AP editions, please include separately.
Would the district prefer one submission with both subject areas, or two submissions – 1)Science and 2) Social Studies?	Our preference would be two submissions (one for social studies and one for science).
Page 4 – Proposal Preparation – Letter B indicates modifications to the proposal must be initialed in	Electronic signatures and initials are okay.

ink. I do not find anywhere that states we must use a wet/ink signature on the required documents. Would you please confirm that we can use electronic signatures? And, if that is affirmative, is it possible to use an electronic initial in the event we have any exceptions?	
Page 23 – Evaluation Criteria, Page 28 Scope, and Page 30 Submittal Requirements indicate “Alignment with state standards”. Would you like respondents to include correlations as URL links in the response documents, or include the completed documents within the response?	Standards correlation documents should be included within the response.
How many sets of samples would you like to receive by August 1 <sup>st</sup> ?	Please include at least one student edition and one teacher’s edition for each course.
Page 24 – 1 <sup>st</sup> full paragraph indicates “Classroom teachers will pilot materials in class.” Are you able to expand on the anticipated piloting process? For example, how many teachers/students/classes will pilot at each grade and course? The tentative schedule states Sept 1, 2022-February 29, 2023 as a teacher pilot period – will it go that entire time, or only be for a period of that time?	Different teachers who teach the same course will typically pilot the same unit or set of lessons from different publishers and then collect data from students and share their thoughts about the materials. It will only be for a period of time during the September – February window.
Do you have a link to the course descriptions? I am looking for Advanced Placement US Government.	LHHS currently is not offering AP Gov’t but is intending to offer it after the adoption. The text should align to College Board AP Government and Politics Course Overview.
Could give me an understanding around how important it is to have "printed" samples for the RFP adoption review.	If there are printed teacher and student materials, please supply those. If there are only digital materials, please supply online access codes.
Page 28 contains the bullet “Preview Specifications”. Is this in respect to demo access for reviewers or something else?	This would be related to demo access and information about what exactly we are previewing.
