A copy of the Notice and Certificate as to same was duly filed in the records of the Corporation with the Minutes of this meeting.

#### **School Bond Issuance**

Thereupon, the following was presented to the Board of Directors:

A resolution of the Board of Directors of the Meade County School District Finance Corporation, providing for the issuance of \$8,320,000 principal amount (which may be increased or decreased by the amount of \$830,000) of school building refunding revenue bonds, series of 2012 (the refunding bonds) in accordance with Sections 162.120 through 162.290 and 58.180 of the Kentucky Revised Statutes, for the purpose of retiring prior to their respective maturities certain of the outstanding Meade County School District Finance Corporation School Building revenue bonds, series of 2012, dated on June 1, 2012 (the prior issue) through the deposit and investment in escrow of the net proceeds of the refunding bonds;, providing for the creation of certain funds to effect the

defeasement of the rights of the owners of certain of the bonds of the prior issue and the transfers of certain amounts into certain funds; providing for the rights of the registered owners of said refunding bonds and the enforcement thereof; authorizing and approving the execution of continuing disclosure procedures; and providing for an advertised public competitive sale of said refunding bonds.

Thereupon, it was moved by Bryan Honaker with second by Steve Orr that said Resolution, be adopted, and that the Superintendent and Chairman be approved to sign all necessary documents. The yea and nay vote was then taken on the motion, and resulted as follows:
