- I. CALL TO ORDER: The meeting was called to order by Megan Evenson-Board Chair at 6:00 pm
- A. Flag Salute
  - B. Agenda Review: We have a revised agenda, with the addition of the Superintendent search update and board reports.
- II. COMMUNICATIONS AND HEARINGS OF INTERESTED PARTIES

- A. Staffing: K. Engel and K. Harris met with J. Carlile last Thursday and discussed Brad Thorud's possible contract and the best way to move forward. They recommend to reverse the previous board's decision and re-instate Mr. Thorud.

- B. Superintendent search update: Mr. Carlile updated the board on the search for a new Superintendent. We are working from behind, as most schools advertise in January and have someone hired by now. Our process will be very different than if we started earlier, it is crunch time. We have advertised and have 3 or 4 candidates so far, but nothing solid except some maybes. C. Ouellette asked what we do if we don't find someone, as Mr. Carlile is done on June 30<sup>th</sup>. That really isn't an option, the ESD may have to appoint another superintendent. We are hoping to meet with one of the candidates as soon as possible.
- IV. BOARD REPORTS: K. Engel updated us on the Senior Award Night held on Monday, June 4<sup>th</sup>. It was well planned, the staff was great, it was a wonderful event. She also discussed the wonderful support from the community in the CES Principal issue, but it is time to move on now and create two great schools and one great district. K. Harris agreed with K. Engel. The awards night yielded over \$400,000 in scholarships to our senior class. She agreed that we need to move forward as one district and bring the community and schools together.
