School Responsibilities

Chastang-Fournier K-8 School will:

- Provide regular elementary and middle curriculum, AMSTI, and STEM, and do so in a supportive and effective learning environment
- A variety of resources and instructional strategies will be used to master objectives, and lessons will incorporate manipulatives and technology as much as possible based on assessment driven data

**2. Hold parent-teacher conferences (at least annually in elementary and middle schools) during which this compact will be discussed as it relates to the individual child's achievement**

*Specifically, those conferences will be held:*

- Partnership conferences on state test date will be held beginning October for Statewide Parenting month
- Teachers may contact parents for additional conferences as needed
- Parents may request conferences by completing the conference request form in the main office or emailing the teacher

**3. Provide parents with frequent reports on their children's progress**

*Specifically, the school will provide reports as follows:*

- Parents will be notified of their child's academic progress quarterly by report card
- Schoology access is also available to check grades online

**4. Provide parents reasonable access to staff**

*Specifically, staff will be available for consultation with parents as follows:*

- Parents may request conferences by contacting faculty and staff via telephone, note/letter, email, Schoology or through the school's website
- Faculty and staff will make every effort to contact parents within 24 hours if possible

- Parents may assist individually or in groups as guided by faculty/staff
- Parents are encouraged to participate on the Parent Advisory Board
- Parents may observe classroom activities with prior administrator approval

- Communicator folders will be provided for every elementary student that includes behavior and written correspondence between teacher and parent
