### **School Responsibilities**

#### **The William L. Radney Elementary School will:**

- *Regularly assess both teacher and students' performance and adjust curriculum and instruction as needed.*
- *Assure that all materials necessary for instruction are available in the classroom*
- *Continually monitor students' academic and social progress.*
- *Seek to continually improve professional competence and skills of all teachers by scheduling ongoing professional development activities.*

**2. Hold parent-teacher conferences as needed, host academic parent teacher team events and parent workshops at minimum three times a year, during which this compact will be discussed as it relates to the individual child's achievement.**

- *At a minimum, three parent meetings with discussions related to this compact and the achievement level of the student. Additionally, parent conferences will be scheduled throughout the year as needed.*

**3. Provide parents with frequent reports on their children's progress.** Specifically, the school will provide reports as follows:

- *Provide regular graded work and progress reports to parents at least once every 5 weeks through student distribution and/or parent mailings.*
  - *Report cards will be sent home at the end of each nine week grading period.*
  - *Student progress will be immediately accessible using PowerSchool.*
  - *Progress reports for those students who receive interventions through the Problem Support Team will be sent home.*
- 4. Provide parents reasonable access to staff.** Specifically, staff will be available for consultation with parents as follows:
- *Staff will be available for consultation with parents as needed and scheduled during planning periods, before school, after school, or upon request.*
- 5. Provide parents opportunities to volunteer and participate in their child's class, and to observe classroom activities, as follows:**
- Parents are also encouraged to join our Parent Teacher Organization and volunteer with the many functions that PTO sponsors. Parents are invited to contact their child's teacher to volunteer their time to help with classroom activities.*
- 6. Ensure regular two-way, meaningful communication between family members and school staff, and, to the extent practicable, in a language that family members can understand.**
- *Parents are provided communication in their native language regularly via Blackboard.*
  - *The school wide teacher -parent communication platform is ClassDojo.*
  - *The school will survey families of English Language Learners at least once a year to gather perception data.*
  - *The principal and other school administrators can be reached by the parent with a visit or phone call to the school's main office, translations are provided to the parents in their native language .*
  - *The school and PTA/parent group make it easy for parents and families to build connections and communicate with each other by providing all information in their native language and by seeking ways that the communication can be improved.*

### **Parent Responsibilities**

**We, as parents, will support our children's learning in the following ways:**

- *Seeing that my child is on time, has healthy meals, and attends school regularly.*
- *Talking with my child regularly about school work and activities, including making sure that homework is completed.*
- *Monitoring television watching and out-of-school activities.*
- *Volunteering at school through class projects, school-wide committees, and/or PTA activities in my child's classroom.*
- *Participating, as appropriate, in decisions relating to my children's education.*
- *Promoting positive use of my child's extracurricular time.*
- *Staying informed about my child's education and communicating with the school by promptly reading all notices from the school or the school district either received by my child or by Class Dojo and responding, as appropriate.*

- *Serving, to the extent possible, on advisory groups, such as Title I advisory committees and parental involvement committees.*
- *Reading and discussing the Student/Parent Resource Guide and Code of Student Conduct with my child.*
- *Reviewing and signing Leadership Notebooks and/or Student Planners each evening.*
- *Discussing work assignments and report cards.*
- *Attending school conferences & meetings.*
