A. Climatec Update – Dr. Price presented the Climatec update:

Projected savings: \$94,403 Actual savings: \$133,653

We saved 142% exceeding the guaranteed 100% by 42%. We reduced Kilowatt hours by 14%.

5. ACTION ITEM

A. 2014-15 FY Budget Revision #1

Mr. Hamm presented 2014-15 FY budget vision #1. He indicated he made adjustments to the budget to match the state's numbers; there were delays due some invoices. We are presently at 3 1/2% carryforward. District Annual Assistance Reduction (DAA) from the state was built on 4%. We're doing very well with \$382,000 carryforward. An ongoing goal is to maintain the

4% carryforward along with the ongoing identification of additional FTE for next year. **MOTION:** Dr. Livingston made a motion to approve the 2014-15 FY Budget Revision #1 as presented. Mr. Ruiz seconded; the motion carried unanimously.

B. Superintendent's Performance review

There are no changes to report. Dr. Price is achieving at a very high level. There are still one or two areas that are ongoing. Mrs. Place publically thanked Dr. Price for the exceptional service to the District.
