Parents will learn about their role in helping their child to be successful and the best ways to work in partnership with their child's teachers. Citronelle High School will invite parents to participate in leadership meetings where decisions are made about academics. CHS will provide literature for parents in the school's parenting center that will assist then with helping their students with academics, social issues, technology concerns, and other relevant issues.

Parents participate in parent meetings and activities held quarterly, such as ACT, pre-ACT, FAFSA, math and literacy nights, STEM and other academic offerings to support their student.

During the opening months of school, Citronelle High School holds its required annual meeting for parents to explain the Title I process and the CHS participation with it. Parents are notified of the meeting through notices sent home with students, the schools social media outlets, and with the electronic message board outside the school. Because of district restrictions on the number of outside visitors that a facility may host at a given time, the meeting was conducted virtually. A recording of that meeting is hosted by the school's website, and its Facebook page.

Topics included what it means to be a Title I school, the 1% setaside, the Title I plan, the LEA parent involvement plan, the ACIP, the CHS parent involvement plan, parent compacts, and other required information.

Citronelle High School believes in involving parents in all aspects of its Title I programs. Our process for how parents have the opportunity for involvement in decision making is as follows: We have a staff member that has been trained or Title I, Part A, parental involvement and parent's rights. She serves as a representative of decisionmaking committees and as the contact person for the Title I parents to answer questions about parent involvement and parent's rights. She keeps parents informed of the work of various committees, and receives input from parents for committee decisions. She assists in evaluating the parental involvement plan. Title I parents are introduced to the parent leaders at the annual meeting of our Title I parents. Parents are informed of involvement activities regularly. Parents are encouraged to become parent leaders and representatives.

Citronelle High School uses its parental involvement funds to fund all materials and supplies for parenting activities.

They also learn how to schedule conferences with teachers, counselors and administrators and are reminded about how to participate in the educational decisions made for their children. Documents are provided to the extent practicable, and in languages other than English as available. The District provides TransAct Translation Services.

Citronelle High School develops its compact for each school year through a coordinated effort by school staff members, our school's Title I Parent Advisory Committee, and two students. All parents will be given access to a digital copy of the new compact at our annual Title I parents' meeting. Those not attending will be instructed how to access the compact. The compact will be explained to the parents and they will be asked to sign the compacts signifying their commitment to working in partnership with the school in ensuring that their child is successful in school. The compacts will be discussed with teachers in faculty meetings. Each teacher will be given the responsibility to explain the compact to the students and obtain the student's signature. The school will house an electronic copy of the compacts; a copy will be on file in the school office for use during parent-teacher and/or student-teacher conferences.

May of each year, Citronelle High School brings in its Leadership Team to review, evaluate, and revise its Continuous Improvement Plan. There are two parents on the Committee who represent all the parents of the school. During the review process, all parents are notified of the review through notices sent home and through social media. The notices make parents aware that the plan is under review, that a copy of the plan is available through the library, office and on the website, and that parents have the right to give input regarding the revision of the plan. The notice also states that after the plan is finalized and approved, parents have the right to submit any concerns with the plan in writing to the school, and the school will submit their concerns to the Central Office at the same time that the CIP is submitted.
