Re: Supplement to Executive Order No. 5 – Out of State Travel and Relocation

This Supplement adds to the enforcement of Amended Executive Order No. 5 issued August 6, 2021.

- 1. Out-of-State Members, Family, and Others Wanting to Visit the Pueblo. Non-resident Pueblo members and family who want to visit from out-of-state must be fully vaccinated, present proof of such vaccination to the EOC, and, upon arrival, present a negative COVID test taken within the previous 5 days. This vaccination requirement does not apply to children not yet eligible for vaccination nor those for whom a medical professional has determined vaccination is not recommended. The negative COVID test requirement does apply to all children.
- 2. <u>Members and Family Wanting to Relocate to the Pueblo</u>. In addition to obtaining the required approval from village officials, any Pueblo member or family wishing to move to the Pueblo to reside, regardless of where their previous residence was, must comply with the vaccination and testing requirements in Section 1 of this supplement.
- 3. <u>Out-of-State Travel</u>. Any Pueblo resident or employee of the Pueblo government or a Pueblo-located enterprise (regardless of where the employee lives) who travels out-of-state must follow these requirements.
  - A. <u>Before leaving</u>: Pueblo residents and tribal government employees must contact the EOC at 505-328-5682 to obtain instructions for COVID safe practices while traveling. Non-residents employed by Pueblo-located enterprises should contact their employer for proper CSP guidance/instruction.
  - B. After returning, all residents and employees must:
    - 1. Obtain a COVID-19 test as soon as possible. Tests are readily available through the EOC.
    - 2. Self-monitor for COVID symptoms including: fever or chills, cough, shortness of breath or difficulty breathing, fatigue, muscle or body aches, headache, new loss of taste or smell, sore throat, congestion or runny nose, nausea or vomiting, diarrhea.
    - 3. Obtain KN-95 masks (available from the EOC) and use one properly when at-work and outside the home.

- 4. Refrain from leaving the home or being in public unnecessarily for at least five days. Neither quarantine nor leave from work are required under this supplement except when an individual has symptoms or a positive COVID-19 test.
- 5. Obtain a second COVID-19 test at least five days after the first and present the results to EOC if that test is not performed by EOC. Submitting a second negative test completes out-of-state travel requirements.

Failure to comply with this supplement shall be a violation of Amended Executive Order No. 5 subject to criminal prosecution or civil liability.
