Background - The Warren/Alvarado/Oslo Strategic Plan is a comprehensive, long term plan which defines the district's beliefs, mission, vision, goals, and objectives to support and improve teaching, student learning and achievement for all student groups. Gail Gilman, MSBA Director of Strategic Planning and Board Leadership guided the WAO School Board and Strategic Planning Committee, made up of internal and external stakeholders, through a two-month planning process to assess the current status of the school district and to develop a strategic plan for the district's future.

The planning process included internal and external surveys, listening sessions, focus groups, developing foundational elements (Belief Statements, Mission Statement, Vision Statement), and identifying future goals and objectives which has become the foundation of the WAO Strategic Plan.
