 - Know what's up
 - Spot Red flags
 - Make a move
 - Talk it up
 - No Shame/no blame
 - Safe Adults
- Covers: Abuse, bullying, cyberbullying, digital safety, reporting and Recognizing abuse and neglect
- Additional programs:
 - o After school Matters for schools and Youth serving organizations
 - Athlete Safety Matters for Youth Sports Programs
 - Mental Health Matters (K-12): Addresses alcohol, vaping, nicotine, drugs, keeping bodies healthy and safe, making good choices to keep bodies and brains healthy and safe, metal health and healthy relationships. The curriculum changes as it gets in the high grades.
