- YTD donations from report: \$7,325.90
- Strong healthy cash balance and cash flow
- Funds still some ESSER to use before September
- Fund Balance is very good 35.5%
- Question: Employee Retention Credit balance is still sitting there how long? Joe knows of one challenge but they successfully defended – he anticipates more organizations will get some pushback, so recommends keeping it there until the summer
- Title window opened up last Friday and Alyssa, Chris, and Joe are working on it.
- Overall, things are where they should be, tracking as expected
