

PAINTER

BASIC FUNCTION:

Under the direction of the Director of Facilities and Operations, perform a variety of skilled duties involved in the maintenance, repair, alteration and painting of District buildings and facilities; remove graffiti from District buildings and facilities.

REPRESENTATIVE DUTIES:

- Paint District buildings and facilities to maintain proper appearance; mix and match paints; erect rigs and move scaffolds and platforms. **E**
- Inspect grounds and remove graffiti from walls, doors and windows; utilize appropriate graffiti removal equipment and chemicals as needed. **E**
- Prepare wood and metal surfaces for painting by sanding, scraping, burning, sandblasting, washing, dusting and filling. **E**
- Utilize brush, roller or spray gun in applying paint, varnish, shellac, enamel, lacquer and other protective and decorative finishes to a variety of surfaces, including wood, metal, plaster, stucco, wallboard, brick and cement. **E**
- Apply primers and finish coats with brushes, spray machines and rollers. **E**
- Estimate time and material for assigned projects; maintain routine records related to work activities; communicate with vendors in the purchase of materials; maintain inventory of equipment, materials and supplies. **E**
- Refinish furniture, doors, lockers and general equipment. **E**
- Paint traffic markings and letter signs utilizing a line-marking machine; paint lines on tracks as assigned. **E**
- Operate, clean and maintain equipment such as brushes, rollers, line marking machines, and others; assure proper working condition of equipment. **E**
- Drive to various District sites to conduct work. **E**
- Assure compliance with environmental, health and safety codes and standards.
- Perform related duties as assigned.

KNOWLEDGE OF:

Trade tools, equipment, materials, methods and techniques used in skilled painting maintenance and repair work.

Appropriate health and safety precautions and procedures.

Laws, codes, rules and regulations related to assigned work.

Methods of preparing a variety of surfaces for painting and finish work.

Technical aspects of field of specialty.

Proper methods of storing equipment, materials and supplies.

Requirements of maintaining school buildings in a safe, clean and orderly condition.

ABILITY TO:

Provide a DMV printout dated within 2 months.
Perform a variety of skilled duties involved in the maintenance, repair, alteration and painting of District buildings and facilities.
Prepare a variety of surfaces for painting or other surface coverings.
Erect and work from scaffolding, riggings and ladders.
Understand and apply painting trade safety standards and procedures.
Understand and follow oral and written directions.
Use a variety of tools and equipment utilized in the painting trade.
Maintain tools and equipment in a clean and proper working condition.
Communicate effectively with others.
Maintain routine records.
Establish and maintain cooperative and effective working relationships with others.

EDUCATION AND EXPERIENCE:

Graduation from high school and two years journey-level painting experience.

LICENSES AND OTHER REQUIREMENTS:

Valid California driver's license.

WORKING CONDITIONS:**ENVIRONMENT:**

Indoor and outdoor environment.
Fumes, dust and odors.
Adverse weather conditions.
Driving a vehicle to conduct work.

PHYSICAL ABILITIES:

Heavy physical labor.
Climbing ladders and scaffolding.
Seeing to perform painting work.
Lifting, carrying, pushing and pulling heavy objects.
Walking.
Reaching overhead, above the shoulders and horizontally.
Dexterity of hands and fingers to operate a variety of tools and equipment used in the trade.
Bending at the waist, kneeling or crouching.

HAZARDS:

Working on ladders or scaffolding at heights.
Chemicals including solvents, graffiti remover chemicals, stains, and others.
Working around and with machinery having moving parts.
