Item Title: Memorandum of Understanding with Oregon School Employees Association, Local #52 Regarding Driver Trainer Wages

Presenter: Dr. Bill Fritz, Superintendent

#### Background Information Related to this Issue:

Under the current Collective Bargaining Agreement with OSEA, if a regular driver serves as a driver trainer (training aspiring drivers to do their job), they actually can make less money than they do performing their regular driving job. This is because when becoming a driver trainer, they revert to step one rather than their current step for the regular driving job.

With the shortage of drivers, we are in need of additional driver training time. The Association and District leadership have discussed this matter and have agreed that a regular driver who assumes the role of driver trainer will receive their bus driving experience when determining their "step" level for trainer pay.

### Architect

The Superintendent is engaged in negotiating a contract with an architect firm (Pivot). He will be meeting with them on Nov. 20 to discuss the potential schedule, scope of work, tasks, etc.

This dialogue will include topics such as addressing escalating construction costs, impact on education while the project is in progress, involvement of the school community in design, etc.

# **OSCIM** Grant

The OSCIM Grant Application has already been delivered to the school district. With help from architects, the agreement will be completed and submitted to ODE.

## December 15

Pivot Architecture will Join the School Board Meeting to discuss contracting options: CMGC, Design-Bid-Build, Design/Build, etc.

The Board will be asked to act on a motion (likely in January) if CMGS is selected.

## Bond Sale

The Superintendent has met with Piper Sandler and they are preparing the package. Likely sale date will be in late February.

Prior to that time the "Official Statement" will be prepared and a Ratings Review Process will occur with either S&P or Moodys.

About two weeks after the sale, the final documents will be shared with the School Board for adoption.

## Citizen Oversight Committee

The oversight committee will be established prior to March 2022. The superintendent is researching how other districts have managed this process.

### GENDER IDENTITY & PHYSICAL CHARACTERISTICS ASSOCIATED WITH RACE

#### Summary

House Bill (HB) 2935 added an aspect to the definition of discrimination in ORS 659.850 for race that includes physical characteristics historically associated with race such as natural hair and hair texture (see new footnote in AC and JB for full language). Another bill, HB 3041, revised the definition of sexual orientation and added a new definition for gender identity to the protected classes. Both of these bills affected change represented in the attached model policies.

A change created by HB 2935 that is not reflected by policy changes but is still important for districts, the bill created additional criteria a school district must ensure when paying fees to a voluntary organization. In addition to the complaint policy requirements imposed on these voluntary organizations in 2019, these policies must now be equity focused. Voluntary organizations must have policies that prohibit discrimination as defined in ORS 659.850, which now includes physical characteristics related to race such as natural hair or hair texture. These equity focused policies must now also permit a student to wear religious clothing when consistent with any safety and health requirements, which will be balanced based on reasonable accommodation needs of participants for a specific activity. Further, the HB adds a provision regarding employer driven dress code or policy, amending ORS 659A.030(5), that they cannot create "a disproportionate adverse impact on members of a protected class to a greater extent than the policy impacts persons generally" (HB 2935, 2021).

#### DEFINITIONS FOR CHILD ABUSE AND SEXUAL CONDUCT

#### Summary

Recent revisions to ORS 339 affecting reporting of child abuse and sexual conduct were adopted by the 2021 Legislature. The passing of these bills revised the definition of 'sexual conduct' and 'licensed administrator' as it relates to reporting and helps define the persons who can be designated to receive and respond to these reports. Additionally, a new definition was added for 'commission licensee' to distinguish between district employees suspected of sexual conduct that shall be reported to and investigated by TSPC and those that shall be reported to and investigated by ODE. The effective date of these changes are immediate.

Additionally, because of the requirements of staff involved in child abuse reporting, a second code has been added to model policy JHFE and its administrative regulations. This policy can now be inserted into section G (if desired) of the board's policy manual and support informing staff of these reporting requirements.

#### LANGUAGE ARTS AND ESSENTIAL SKILLS

#### **Summary**

The 2021 Oregon Legislature updated statute in ORS 329.451 (House Bill 2056) modifying Oregon diploma requirements by changing 'English language arts' to 'language arts' and redefining definitions for language arts, world languages and holocaust and genocide studies. Statute updates to ORS 329.045 made changes to the required characteristics of a school system and to Essential Skills.

Senate Bill 744 (2021) has suspended the requirement for a student to show proficiency in Essential Skills as a condition of receiving a high school diploma for the 2021-2022, 2022-23 or the 2023-2024 school year.

Lastly, there has been two versions of policy for IKF – Graduation Requirements and an AR to accompany version 2. The decisions was made to maintain one version of IKF – Graduation Requirements and remove the alternate version (2) and the AR from the model samples, leaving one version of model policy IKF. The designation for IKF – Graduation Requirements has been changed to *conditionally required* because the district is required to adopt policy if the district has established additional credit and/or graduation requirements above the state-adopted graduation requirements for any state described diploma or alternative certificate.



# Logger Sports have a Successful Fall Season

After a season last year when volleyball, cross country, and football were in the spring and seasons were only five weeks long, we finally have had a normal fall sports season. Not surprisingly, Logger sports are back on a roll. After "playing up" against 3A Warrenton, the football team went on a roll, outscoring opponents by a margin of 292-65. In the final regular season game, we played against Gaston to move ahead in the state rankings from 7<sup>th</sup> place to 5<sup>th</sup> place. This game also placed us as the undefeated Champion of the 2A Northwest League. This seeding placed us with a home field advantage for last Friday's playoff game against Jefferson. That game was on a cool and breezy night, and the game was low-scoring, with the Loggers being defeated 12-6. In a show of good sportsmanship, the Knappa team offered a signed game ball to a player from Jefferson who had lost his father during the previous week.

## **High School Success**

Amongst all of the fall hoopla over sports this fall, some people in Knappa may have overlooked our academic success. When school report cards were released last month, Knappa topped the county's large districts in freshmen on track rate AND graduation rate. Knappa's graduation rate was 93%, topping the three larger districts in Clatsop County and beating the state rate of 83%. Knappa's freshmen on track rate (the percentage of ninth graders who are on track to graduate on time) is 90%, again topping the county's larger districts and beating the state rate of 74%.

Knappa School District has a dedicated team of leaders and teachers who work hard to track the progress of our students and find ways to individually create plans of action on how to help, mainly through personalization.
